A BILL FOR AN ACT

101 **CONCERNING PROHIBITING A MENTAL HEALTH CARE PROVIDER FROM**
102 **ENGAGING IN CONVERSION THERAPY WITH A PATIENT UNDER**
103 **EIGHTEEN YEARS OF AGE.**

Bill Summary

The bill prohibits a licensed physician specializing in psychiatry or a licensed, certified, or registered mental health care provider from engaging in conversion therapy with a patient under 18 years of age. A licensee who engages in these practices is subject to disciplinary action by the appropriate licensing board. The bill also makes the advertising or

practice of conversion therapy by a physician or mental health care provider a deceptive trade practice under the "Colorado Consumer Protection Act". "Conversion therapy" means efforts to change an individual's sexual orientation, including efforts to change behaviors or gender expressions or to eliminate or reduce sexual or romantic attraction or feelings toward individuals of the same sex.

15 **SECTION 9. Act subject to petition - effective date.** (1) Except
16 as otherwise provided in subsection (2) of this section, this act takes
17 effect at 12:01 a.m. on the day following the expiration of the ninety-day
18 period after final adjournment of the general assembly (August 2, 2019,
19 if adjournment sine die is on May 3, 2019); except that, if a referendum
20 petition is filed pursuant to section 1 (3) of article V of the state
21 constitution against this act or an item, section, or part of this act within
22 such period, then the act, item, section, or part will not take effect unless
23 approved by the people at the general election to be held in November
24 2020 and, in such case, will take effect on the date of the official
25 declaration of the vote thereon by the governor.

26 (2) Sections 5, 6, 7, and 8 of this act take effect only if House Bill

- 1 19-1172 becomes law, in which case sections 5, 6, 7, and 8 take effect
- 2 October 1, 2019.
