A BILL FOR AN ACT

101 **CONCERNING CONTRACTING BY THE COLORADO STUDENT LOAN**
102 **PROGRAM FOR THE ADMINISTRATION OF THE COLLEGE**
103 **OPPORTUNITY FUND PROGRAM.**

Bill Summary

Legislative Audit Committee. The bill permits the Colorado student loan program (program) to enter into an agreement with the department of higher education or another state entity to administer part or all of the college opportunity fund program. The program's authority to contract is effective on and after July 1, 2015.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 23-18-201, **amend**
3 (1) as follows:

4 **23-18-201. College opportunity fund program - creation -**
5 **eligibility - guidelines.** (1) There is ~~hereby~~ created in the department of
6 higher education the college opportunity fund program, which ~~shall be~~ IS
7 administered by the Colorado student loan program. ON AND AFTER JULY
8 1, 2015, THE COLORADO STUDENT LOAN PROGRAM MAY ENTER INTO AN
9 AGREEMENT WITH THE DEPARTMENT OR ANOTHER STATE ENTITY TO
10 ADMINISTER ALL OR PART OF THE COLLEGE OPPORTUNITY FUND PROGRAM.
11 The college opportunity fund, created in section 23-18-202, ~~shall be~~ IS a
12 trust fund for the benefit of eligible undergraduate students. It ~~shall~~
13 ~~consist~~ CONSISTS of a stipend for each undergraduate student in Colorado
14 who applies for the stipend and who is admitted and registers to attend a
15 state or participating private institution of higher education and is
16 determined to be eligible by the Colorado student loan program to receive
17 a stipend. An eligible undergraduate student may use the stipend for
18 undergraduate courses and graduate-level courses that apply toward the
19 student's undergraduate degree that are taken at a state or participating
20 private institution of higher education at a fixed rate per credit hour, set
21 annually by the general assembly.

22 **SECTION 2.** In Colorado Revised Statutes, 23-3.1-106, **add** (4)
23 as follows:

24 **23-3.1-106. Student loan program established.** (4) ON AND
25 AFTER JULY 1, 2015, THE COLORADO STUDENT LOAN PROGRAM MAY
26 ENTER INTO AN AGREEMENT WITH THE DEPARTMENT OR ANOTHER STATE

1 ENTITY TO ADMINISTER ALL OR PART OF THE COLLEGE OPPORTUNITY FUND
2 PROGRAM CREATED IN PARTS 1 AND 2 OF ARTICLE 18 OF THIS TITLE 23.

3 **SECTION 3. Safety clause.** The general assembly hereby finds,
4 determines, and declares that this act is necessary for the immediate
5 preservation of the public peace, health, and safety.
