1           **SECTION 2. Appropriation to the office of the governor for**

5           Section 15. **Appropriations.** (1) For the 2020-21 state fiscal year,

8 office. This appropriation is from the digital inclusion grant program fund

11 Colorado broadband office may use this appropriation to implement the  
12 digital inclusion grant program created in section 24-37.5-904 (1)(a),  
13 C.R.S. Any money appropriated in this subsection (1) not expended prior  
14 to ~~July 1, 2021~~ JULY 1, 2022, is further appropriated to the office of the  
15 governor for use by the office of information technology for the ~~2021-22~~  
16 2022-23 state fiscal year for the same purpose.

17           (2) For the 2020-21 state fiscal year, \$35,000,000 is appropriated  
18 to the office of the governor for use by the office of information  
19 technology for the broadband deployment board. This appropriation is  
20 from the broadband stimulus account in the broadband administrative  
21 fund created in section 24-37.5-119 (4), C.R.S., and of money the state  
22 received from the federal coronavirus state fiscal recovery fund. The

2           **SECTION 3. Safety clause.** The general assembly hereby finds,  
3 determines, and declares that this act is necessary for the immediate  
4 preservation of the public peace, health, and safety.
