5	Section 16. <b>Appropriation.</b> (3) For the 2021-22 state fiscal year,
6	\$1,000,000 is appropriated to the department of higher education. This
7	appropriation is from the workers, employers, and workforce centers cash
8	fund created in section 24-75-231, C.R.S., and of money the state
9	received from the federal coronavirus state fiscal recovery fund, and is
10	based on an assumption that the department will require an additional 1.0
11	FTE. To implement this act, the department may use this appropriation
12	for the Colorado re-engaged initiative created in section 23-1-131.5,
13	C.R.S., and the associate degree completion program described in section
14	23-1-131, C.R.S. ANY MONEY APPROPRIATED IN THIS SUBSECTION (3) NOT
