A BILL FOR AN ACT

101 **CONCERNING THE INCLUSION OF CONSERVATION STANDARDS IN THE**
102 **PLUMBING CODE.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill requires the plumbing code adopted by the examining board of plumbers in the department of regulatory agencies to include standards for water efficiency and conservation, water-efficient fixtures and installation guidelines, and the use of locally produced materials.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** 12-58-102 (4), Colorado Revised Statutes, is
3 amended, and the said 12-58-102 is further amended BY THE
4 ADDITION OF A NEW SUBSECTION, to read:

5 **12-58-102. Definitions.** As used in this article, unless the context
6 otherwise requires:

7 (4) "Colorado plumbing code" means a code established by the
8 board that consists of standards for plumbing installation, plumbing
9 materials, CONSERVATION, medical gas, sanitary drainage systems, and
10 solar plumbing that could directly affect the potable water supply.

11 (4.5) (a) "CONSERVATION" MEANS EFFICIENCY MEASURES THAT
12 MEET NATIONAL GUIDELINES AND STANDARDS AND ARE TESTED AND
13 APPROVED BY A NATIONALLY RECOGNIZED TESTING LABORATORY,
14 INCLUDING:

15 (I) WATER-EFFICIENT DEVICES AND FIXTURES; AND

16 (II) THE USE OF LOCALLY PRODUCED MATERIALS, WHEN
17 PRACTICABLE, TO REDUCE TRANSPORTATION IMPACTS.

18 (b) WHEN CONSERVATION CONFLICTS WITH SAFETY, THE BOARD
19 SHALL GIVE PRIMARY CONSIDERATION TO SAFETY.

20 (c) NOTHING IN THIS SUBSECTION (4.5) AFFECTS THE BOARD'S
21 AUTHORITY TO ESTABLISH THE COLORADO PLUMBING CODE AS SPECIFIED
22 IN SECTION 12-58-104.5.

23 **SECTION 2. Act subject to petition - effective date -**
24 **applicability.** (1) This act shall take effect at 12:01 a.m. on the day
25 following the expiration of the ninety-day period after final adjournment
26 of the general assembly (August 11, 2010, if adjournment sine die is on

1 May 12, 2010); except that, if a referendum petition is filed pursuant to
2 section 1 (3) of article V of the state constitution against this act or an
3 item, section, or part of this act within such period, then the act, item,
4 section, or part shall not take effect unless approved by the people at the
5 general election to be held in November 2010 and shall take effect on the
6 date of the official declaration of the vote thereon by the governor.

7 (2) The provisions of this act shall apply to a rule modifying the
8 Colorado plumbing code that occurs pursuant to the regular schedule of
9 the examining board of plumbers that is promulgated on or after the
10 applicable effective date of this act.
