1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** 12-22-121, Colorado Revised Statutes, is amended  
3 BY THE ADDITION OF A NEW SUBSECTION to read:

4 **12-22-121. Compounding - dispensing - sale of drugs and**  
5 **devices - rules.** (19) A PRESCRIPTION DRUG OUTLET MAY ALLOW A  
6 LICENSED PHARMACIST TO REMOVE IMMUNIZATIONS AND VACCINES FROM  
7 THE PRESCRIPTION DRUG OUTLET FOR THE PURPOSE OF ADMINISTRATION  
8 BY A LICENSED PHARMACIST, OR AN INTERN UNDER THE SUPERVISION OF  
9 A PHARMACIST CERTIFIED IN IMMUNIZATION, PURSUANT TO RULES  
10 PROMULGATED BY THE BOARD. THE BOARD SHALL PROMULGATE RULES  
11 REGARDING THE STORAGE, TRANSPORTATION, AND RECORD-KEEPING OF  
12 IMMUNIZATIONS AND VACCINES THAT ARE ADMINISTERED OFF-SITE.

15 **SECTION 2. Act subject to petition - effective date.** This act  
16 shall take effect at 12:01 a.m. on the day following the expiration of the  
17 ninety-day period after final adjournment of the general assembly (August  
18 11, 2010, if adjournment sine die is on May 12, 2010); except that, if a  
19 referendum petition is filed pursuant to section 1 (3) of article V of the  
20 state constitution against this act or an item, section, or part of this act  
21 within such period, then the act, item, section, or part shall not take effect  
22 unless approved by the people at the general election to be held in

1 November 2010 and shall take effect on the date of the official  
2 declaration of the vote thereon by the governor.
