101 **CONCERNING THE CONTINUATION OF LICENSING REQUIREMENTS FOR**  
102 **MESSAGE THERAPISTS, AND, IN CONNECTION THEREWITH,**  
103 **IMPLEMENTING THE RECOMMENDATIONS OF THE 2021 SUNSET**

massage therapists by:

- Continuing the licensing requirements for 9 years, until September 1, 2031 (**sections 1 and 2** of the bill);
- Granting sole discretion to the director of the division of professions and occupations to approve the licensure examination for massage therapists by repealing the reference to national licensure examinations as an option for massage therapist applicants to take in lieu of another examination approved by the director (**section 3**); and
- Adding, as grounds for disciplining a massage therapist:
  - Engaging in fraud, misrepresentation, deception, or cheating in taking or furnishing the results of a required examination or having the person's score on the examination invalidated by the testing provider because the person was determined to have cheated or engaged in fraud, misrepresentation, or deception in taking the examination (**section 4**); and
  - Failing to timely respond to a complaint against the massage therapist (**section 4**).

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **amend** 12-235-120  
3 as follows:

4 **12-235-120. Repeal of article - review of functions.** This article  
5 235, and the functions of the director as set forth in this article 235, are  
6 repealed, effective ~~September 1, 2022~~ SEPTEMBER 1, 2031. Before the  
7 repeal, the functions of the director are scheduled for review in  
8 accordance with section 24-34-104.

9 **SECTION 2.** In Colorado Revised Statutes, 24-34-104, **repeal**  
10 (23)(a)(V); and **add** (32)(a)(VII) as follows:

11 **24-34-104. General assembly review of regulatory agencies**  
12 **and functions for repeal, continuation, or reestablishment - legislative**  
13 **declaration - repeal.** (23) (a) The following agencies, functions, or both,  
14 are scheduled for repeal on September 1, 2022:

4           (32) (a) The following agencies, functions, or both, are scheduled

7 OF THE DIVISION OF PROFESSIONS AND OCCUPATIONS IN ACCORDANCE  
8 WITH ARTICLE 235 OF TITLE 12.

9           **SECTION 3.** In Colorado Revised Statutes, 12-235-108, **amend**  
10 (1)(b) as follows:

11           **12-235-108. License - denial of license application.** (1) Every  
12 applicant for a license to practice massage therapy shall:

13           (b) Pass ~~one of the following examinations:~~

14           ~~(I) The massage and bodywork licensing examination offered by~~  
15 ~~the Federation of State Massage Therapy Boards;~~

16           ~~(II) A national certification examination offered by the National~~  
17 ~~Certification Board for Therapeutic Massage and Bodywork; or~~

18           ~~(III) an examination approved by the director;~~

19           **SECTION 4.** In Colorado Revised Statutes, 12-235-111, **amend**  
20 (1)(d)  as follows:

21           **12-235-111. Grounds for discipline - definitions.** (1) The  
22 director is authorized to take disciplinary action pursuant to section  
23 12-235-112 against any person who has:

24           (d) Falsified information in any application; ~~or~~ attempted to obtain  
25 or obtained a license by fraud, deception, or misrepresentation; ENGAGED  
26 IN FRAUD, MISREPRESENTATION, DECEPTION, OR CHEATING IN TAKING OR  
27 FURNISHING THE RESULTS OF THE EXAMINATION REQUIRED BY SECTION

1 12-235-108 (1)(b); OR HAD THE PERSON'S SCORE ON THE EXAMINATION  
2 REQUIRED BY SECTION 12-235-108 (1)(b) INVALIDATED BY THE TESTING  
3 PROVIDER BECAUSE THE PERSON WAS DETERMINED TO HAVE CHEATED OR  
4 ENGAGED IN FRAUD, MISREPRESENTATION, OR DECEPTION IN TAKING THE  
5 EXAMINATION;

7 **SECTION 5. Act subject to petition - effective date.** This act  
8 takes effect September 1, 2022; except that, if a referendum petition is  
9 filed pursuant to section 1 (3) of article V of the state constitution against  
10 this act or an item, section, or part of this act within the ninety-day period  
11 after final adjournment of the general assembly, then the act, item,  
12 section, or part will not take effect unless approved by the people at the  
13 general election to be held in November 2022 and, in such case, will take  
14 effect on the date of the official declaration of the vote thereon by the  
15 governor.
