**A BILL FOR AN ACT**

101 **CONCERNING RESTORATIVE JUSTICE, AND, IN CONNECTION**  
102 **THEREWITH, MAKING AN APPROPRIATION.**

---

**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Under current law, restorative justice victim-offender conferences must be initiated by the victim. The bill modifies the requirement of victim initiation in some instances to permit district attorney or offender initiation. There is a restorative justice coordinating council established in the state court administrator's office; the bill adds:

- ! A member of the parole board;
- ! A representative from the department of corrections;
- ! A representative from a statewide organization representing victims; and
- ! A restorative justice practitioner.

The restorative justice coordinating council shall develop a uniform restorative justice satisfaction evaluation. The council shall collect information regarding all existing restorative justice programs and practices and report that data to the house and senate judiciary committees by January 31, 2014.

The bill creates a pilot project for restorative justice programs in 4 judicial districts. At each site, if a juvenile who is under 18 years of age and could be charged in the petition with a misdemeanor and has not been previously charged or who has not participated in the pilot project, the district attorney shall assess the juvenile's suitability for restorative justice. The district attorney may also refer any juvenile who is charged with a class 3, 4, 5, or 6 felony and has not been previously charged or who has not participated in the pilot project. If the district attorney determines that the juvenile is a suitable candidate for the restorative justice program, the district attorney may offer the juvenile an opportunity to participate in the restorative justice program. If the juvenile agrees to participate, the district attorney shall not file charges pending completion of the program. If the juvenile fails to complete the program, the district attorney may file a petition against the juvenile. The pilot project sites must annually report to the division of criminal justice in the department of public safety certain information on the pilot projects. The division of criminal justice shall prepare an annual report based on the information received.

The bill creates a \$10 surcharge on all crimes to support a restorative justice fund. The fund will be used to defray the costs of restorative justice programs and administrative costs of the restorative justice coordinating council.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 18-1-901, **amend** (3)  
 3 (o.5) as follows:

4           **18-1-901. Definitions.** (3) (o.5) "Restorative justice practices"  
 5 means practices that emphasize repairing the harm caused to victims and  
 6 the community by offenses. Restorative justice practices include  
 7 ~~victim-initiated~~ victim-offender conferences, family group conferences,

1 circles, community conferences, and other similar victim-centered  
2 practices. Restorative justice practices are facilitated meetings attended  
3 voluntarily by the victim or victim's representatives, the victim's  
4 supporters, the offender, and the offender's supporters and may include  
5 community members. By engaging the parties to the offense in voluntary  
6 dialogue, restorative justice practices provide an opportunity for the  
7 offender to accept responsibility for the harm caused to the victim and  
8 community, promote victim healing, and enable the participants to agree  
9 on consequences to repair the harm, to the extent possible, including but  
10 not limited to apologies, community service, reparation, restoration, and  
11 counseling. Restorative justice practices may be used in addition to any  
12 other conditions, consequences, or sentence imposed by the court.

13 **SECTION 2.** In Colorado Revised Statutes, 18-1.3-204, **amend**  
14 (2) (a) (III.5) as follows:

15 **18-1.3-204. Conditions of probation - interstate compact**  
16 **probation transfer cash fund - creation.** (2) (a) When granting  
17 probation, the court may, as a condition of probation, require that the  
18 defendant:

19 (III.5) Participate in restorative justice practices, as defined in  
20 section 18-1-901 (3) (o.5), if available in the jurisdiction, ~~requested by the~~  
21 ~~victim who has been informed about restorative justice practices pursuant~~  
22 ~~to section 24-4.1-303 (11) (g), C.R.S.,~~ and the defendant is  
23 determined suitable by a designated restorative justice practices  
24 facilitator. ~~IF A DEFENDANT WANTS TO PARTICIPATE IN RESTORATIVE~~  
25 ~~JUSTICE PRACTICES, THE DEFENDANT MUST MAKE THE REQUEST TO THE~~  
26 ~~DISTRICT ATTORNEY OR THE LAW ENFORCEMENT AGENCY ADMINISTERING~~  
27 ~~THE PROGRAM AND MAY NOT MAKE THE REQUEST TO THE VICTIM. IF~~

1 REQUESTED BY THE DEFENDANT, DISTRICT ATTORNEY, OR LAW  
2 ENFORCEMENT AGENCY, A VICTIM-OFFENDER CONFERENCE MAY ONLY BE  
3 CONDUCTED AFTER THE VICTIM IS CONSULTED BY THE DISTRICT ATTORNEY  
4 AND OFFERED THE OPPORTUNITY TO PARTICIPATE OR SUBMIT A VICTIM  
5 IMPACT STATEMENT. IF A VICTIM ELECTS NOT TO ATTEND, A VICTIM  
6 OFFENDER CONFERENCE MAY BE HELD WITH A SUITABLE VICTIM  
7 SURROGATE OR VICTIM ADVOCATE, AND THE VICTIM MAY SUBMIT A  
8 VICTIM-IMPACT STATEMENT. To be eligible for restorative justice  
9 practices, the defendant shall not have been convicted of unlawful sexual  
10 behavior as defined in section 16-22-102 (9), C.R.S., a crime in which the  
11 underlying factual basis involves domestic violence, as defined in section  
12 18-6-800.3 (1), stalking as defined in section 18-3-602, or violation of a  
13 protection order as defined in section 18-6-803.5. Any statements made  
14 during a restorative justice conference shall be confidential and shall not  
15 be used as a basis for charging or prosecuting the defendant unless the  
16 defendant commits a chargeable offense during the conference. Failure  
17 to complete the requirements arising from a restorative justice conference  
18 may be considered a violation of probation. Nothing in this subparagraph  
19 (III.5) shall be construed to require a victim to participate in RESTORATIVE  
20 JUSTICE PRACTICES OR a restorative justice victim-offender conference.

21 **SECTION 3.** In Colorado Revised Statutes, 19-1-103, **amend**  
22 (44) as follows:

23 **19-1-103. Definitions.** As used in this title or in the specified  
24 portion of this title, unless the context otherwise requires:

25 (44) "Diversion" means a decision made by a person with  
26 authority or a delegate of that person that results in specific official action  
27 of the legal system not being taken in regard to a specific juvenile or child

1 and in lieu thereof providing individually designed services by a specific  
2 program. The goal of diversion is to prevent further involvement of the  
3 juvenile or child in the formal legal system. Diversion of a juvenile or  
4 child may take place either at the prefiling level as an alternative to the  
5 filing of a petition pursuant to section 19-2-512 or at the postadjudication  
6 level as an adjunct to probation services following an adjudicatory  
7 hearing pursuant to section 19-3-505 or a disposition as a part of  
8 sentencing pursuant to section 19-2-907. "Services", as used in this  
9 subsection (44), includes but is not limited to diagnostic needs  
10 assessment, restitution programs, community service, job training and  
11 placement, specialized tutoring, constructive recreational activities,  
12 general counseling and counseling during a crisis situation, and follow-up  
13 activities. Services may include restorative justice practices as defined in  
14 section 18-1-901 (3) (o.5), C.R.S., ~~as requested by the victim, after being~~  
15 ~~informed about restorative justice practices pursuant to section~~  
16 ~~24-4.1-303 (11) (g), C.R.S.;~~ and as deemed suitable by the probation  
17 department or a designated restorative justice practices facilitator. ■ ■  
18 ~~Such practices may include victim-offender conferences, if requested by~~  
19 ~~the victim.~~ Restorative justice practices shall be conducted by facilitators  
20 recommended by the district attorney.

21 **SECTION 4.** In Colorado Revised Statutes, 19-2-213, **amend** (1)  
22 and (2) (g); and **add** (2) (i), (2) (j), (2) (k), (2) (l), and (2) (m) as follows:

23 **19-2-213. Restorative justice coordinating council -**  
24 **establishment - membership - repeal.** (1) (a) A council to provide  
25 assistance and education related to restorative justice programs is hereby  
26 established. The council shall be known as the "restorative justice  
27 coordinating council" and shall be established in the state judicial

1 department within the office of the state court administrator. To the extent  
2 that resources permit, the restorative justice coordinating council shall  
3 support the development of restorative justice programs, serve as a central  
4 repository for information, assist in the development and provision of  
5 related education and training, and provide technical assistance to entities  
6 engaged in or wishing to develop restorative justice programs.

7 (b) IN ORDER TO ASSESS THE EFFICACY OF RESTORATIVE JUSTICE  
8 PRACTICES IN PROVIDING SATISFACTION TO PARTICIPANTS, THE COUNCIL  
9 SHALL DEVELOP A UNIFORM RESTORATIVE JUSTICE SATISFACTION  
10 EVALUATION BY SEPTEMBER 1, 2013. THE EVALUATION MUST BE BASED  
11 ON RESEARCH PRINCIPLES. THE EVALUATION SHALL INCLUDE A  
12 PRE-CONFERENCE QUESTIONNAIRE TO ESTABLISH A BASELINE AND A  
13 POST-CONFERENCE QUESTIONNAIRE THAT IS SUITABLE TO ADMINISTER TO  
14 RESTORATIVE JUSTICE PARTICIPANTS, INCLUDING COMMUNITY MEMBERS,  
15 PARTICIPATING VICTIMS, AND OFFENDERS.

16 (c) (I) THE COUNCIL SHALL DEVELOP A DATABASE OF EXISTING  
17 RESTORATIVE JUSTICE PROGRAMS IN THE STATE BY DECEMBER 31, 2013,  
18 AND UPDATE IT ANNUALLY BY DECEMBER 31 OF EACH YEAR.

19 (II) THE DATABASE MUST CONSIST OF THE FOLLOWING  
20 INFORMATION:

21 (A) THE LOCATION OF THE RESTORATIVE JUSTICE PROGRAM;

22 (B) THE TYPES OF RESTORATIVE JUSTICE PRACTICES USED IN THE  
23 PROGRAM AND THE COSTS AND FEES ASSOCIATED WITH THE PRACTICES;

24 AND

25 (C) THE BACKGROUND, TRAINING, AND RESTORATIVE JUSTICE  
26 EXPERIENCE OF THE FACILITATORS IN THE RESTORATIVE JUSTICE  
27 PROGRAM.

1 (d) (I) THE COUNCIL SHALL COLLECT INFORMATION REGARDING  
2 RESTORATIVE JUSTICE PRACTICES IN THE STATE AND SHALL REPORT TO THE  
3 JUDICIARY COMMITTEES OF THE SENATE AND HOUSE REPRESENTATIVES BY  
4 JANUARY 31, 2014. THE REPORT MUST INCLUDE INFORMATION ON THE  
5 NUMBER OF CASES IN WHICH RESTORATIVE JUSTICE WAS CONSIDERED,  
6 USED, AND NOT USED, INCLUDING THE DEMOGRAPHIC INFORMATION OF  
7 THE INDIVIDUALS, A DESCRIPTION OF THE RESTORATIVE JUSTICE PRACTICES  
8 USED, AND THE RESULTS OF THE UNIFORM RESTORATIVE JUSTICE  
9 SATISFACTION EVALUATION. THE INFORMATION MUST ALSO BE IDENTIFIED  
10 BY THE COURT EMPLOYING THE RESTORATIVE JUSTICE PRACTICES, BY THE  
11 OUTCOME OF THE RESTORATIVE JUSTICE PRACTICES, AND BY THE POINT IN  
12 THE CRIMINAL OR JUVENILE JUSTICE PROCESS IN WHICH RESTORATIVE  
13 JUSTICE WAS CONSIDERED OR USED.

14 (II) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2014.

15 (2) The restorative justice coordinating council shall include, at  
16 a minimum, the following:

17 (g) A victim's ~~advocate~~ REPRESENTATIVE within the judicial  
18 department with restorative justice experience who shall be appointed by  
19 the state court administrator; ~~and~~

20 (i) A REPRESENTATIVE FROM THE STATE BOARD OF PAROLE  
21 APPOINTED BY THE CHAIR OF THE PAROLE BOARD;

22 (j) A REPRESENTATIVE FROM THE DEPARTMENT OF CORRECTIONS  
23 APPOINTED BY THE EXECUTIVE DIRECTOR OF THE DEPARTMENT OF  
24 CORRECTIONS;

25 (k) A REPRESENTATIVE FROM A NONGOVERNMENT STATEWIDE  
26 ORGANIZATION REPRESENTING VICTIMS APPOINTED BY THE EXECUTIVE  
27 DIRECTOR OF THE DEPARTMENT OF PUBLIC SAFETY; ■

1 (l) THREE RESTORATIVE JUSTICE PRACTITIONERS APPOINTED BY  
2 THE STATE COURT ADMINISTRATOR.

3 (m) A REPRESENTATIVE OF THE JUVENILE PAROLE BOARD  
4 APPOINTED BY THE CHAIR OF THE JUVENILE PAROLE BOARD.

5 **SECTION 5.** In Colorado Revised Statutes, **add** 19-2-510.5 as  
6 follows:

7 **19-2-510.5. Restorative justice pilot project - definitions -**  
8 **repeal.** (1) THE GENERAL ASSEMBLY FINDS THAT:

9 (a) JUVENILES SHOULD BE CONFRONTED WITH AND HELD  
10 ACCOUNTABLE FOR THEIR OFFENDING BEHAVIOR AND GIVEN  
11 OPPORTUNITIES TO TAKE RESPONSIBILITY FOR THEIR ACTIONS BY MAKING  
12 AMENDS TO THE VICTIM AND COMMUNITY;

13 (b) JUVENILE OFFENDING IS OFTEN OPPORTUNISTIC BEHAVIOR,  
14 WHICH IS OUTGROWN;

15 (c) INVOLVEMENT WITH THE JUVENILE JUSTICE SYSTEM CAN BE  
16 DETRIMENTAL TO JUVENILES AND SHOULD BE PREVENTED WHEN POSSIBLE;

17 (d) BY INVOLVING JUVENILES IN RESTORATIVE JUSTICE PRACTICES,  
18 THEY CAN BETTER UNDERSTAND THE EFFECTS OF THEIR CONDUCT IN  
19 HUMAN TERMS;

20 (e) THE JUVENILE JUSTICE SYSTEM SHOULD INCORPORATE  
21 EVIDENCE-BASED PRACTICES DERIVED FROM THE PILOT PROJECT'S  
22 RESEARCH AND DATA;

23 (f) IT IS THE INTENT OF THE GENERAL ASSEMBLY THAT THIS  
24 SECTION:

25 (I) ESTABLISH A PILOT PROGRAM TO FACILITATE AND ENCOURAGE  
26 DIVERSION OF JUVENILES FROM THE JUVENILE JUSTICE SYSTEM TO  
27 RESTORATIVE JUSTICE PRACTICES, BOTH TO PROVIDE DATA TO ASSESS THE



1 EFFICACY OF RESTORATIVE JUSTICE TO REDUCE RECIDIVISM, TO ASSIST IN  
2 REPAIRING THE HARM CAUSED TO VICTIMS AND THE COMMUNITY,  
3 INCREASE VICTIM, OFFENDER, AND COMMUNITY MEMBER SATISFACTION,  
4 AND REDUCE COST; AND TO PROMOTE THE RESTORATIVE JUSTICE  
5 PRINCIPLES OF RECONCILIATION, RESPONSIBILITY, REINTEGRATION,  
6 RESPECT, RELATIONSHIP-BUILDING, AND RESTITUTION; AND

7 (II) FACILITATE AND ENCOURAGE DIVERSION OF JUVENILES FROM  
8 THE JUVENILE JUSTICE SYSTEM WHEN DIVERSION MAY PREVENT JUVENILES  
9 FROM COMMITTING ADDITIONAL CRIMINAL ACTS, RESTORE VICTIMS OF  
10 CRIME, FACILITATE THE JUVENILES' ABILITY TO PAY RESTITUTION TO  
11 VICTIMS OF CRIME, AND REDUCE THE NUMBER OF CASES IN THE JUVENILE  
12 JUSTICE SYSTEM. RESTORATIVE JUSTICE SHOULD ENSURE ACCOUNTABILITY  
13 WHILE ALLOWING JUVENILES TO AVOID THE COLLATERAL CONSEQUENCES  
14 ASSOCIATED WITH CRIMINAL CHARGES AND CONVICTIONS.

15 (2) (a) THERE SHALL BE A RESTORATIVE JUSTICE PILOT PROJECT.  
16 THE PILOT PROJECT CONSISTS OF TWO NEW RESTORATIVE JUSTICE  
17 PROGRAMS IN THE TENTH AND NINETEENTH JUDICIAL DISTRICT AND TWO  
18 EXISTING RESTORATIVE JUSTICE PROGRAMS IN THE TWELFTH AND  
19 TWENTIETH JUDICIAL DISTRICTS.

20 (b) THE PILOT PROJECT SITES DESCRIBED IN PARAGRAPH (a) OF  
21 THIS SUBSECTION (2) MUST PROVIDE TO THE DIVISION OF CRIMINAL JUSTICE  
22 IN THE DEPARTMENT OF PUBLIC SAFETY THE FOLLOWING INFORMATION  
23 BASED ON THE PREVIOUS YEAR BY JULY 1, 2014, AND JULY 1, EACH YEAR  
24 THEREAFTER:

25 (I) A DESCRIPTION OF THE TYPES OF RESTORATIVE JUSTICE  
26 PRACTICES USED AND COSTS ASSOCIATED WITH EACH PRACTICE;

27 (II) THE NUMBER OF JUVENILES IN THE JURISDICTION'S JUVENILE

1 JUSTICE SYSTEM WHO MET THE CRITERIA IN PARAGRAPH (b) OF  
2 SUBSECTION (3) OF THIS SECTION;

3 (III) THE NUMBER OF JUVENILES WHO PARTICIPATED IN THE  
4 RESTORATIVE JUSTICE PROGRAM, INCLUDING DEMOGRAPHIC INFORMATION  
5 CONSISTING OF THE JUVENILE'S AGE, RACE, AND GENDER, AND EACH  
6 CHARGE AT ARREST;

7 (IV) THE NUMBER OF JUVENILES PARTICIPATING IN THE  
8 RESTORATIVE JUSTICE PROGRAM WHO REACHED AN AGREEMENT TO REPAIR  
9 THE HARM AND SUCCESSFULLY COMPLETED THE RESTORATIVE JUSTICE  
10 PROGRAM AND THE NUMBER OF JUVENILES WHO DID NOT COMPLETE THE  
11 RESTORATIVE JUSTICE PROGRAM AND THE REASON FOR NONCOMPLETION;

12 (V) THE RESULTS OF THE UNIFORM RESTORATIVE JUSTICE  
13 SATISFACTION EVALUATION DEVELOPED PURSUANT TO SECTION 19-2-213  
14 (1) (b);

15 (VI) THE NUMBER OF JUVENILES WHO PARTICIPATED IN THE  
16 RESTORATIVE JUSTICE PROGRAM AND HAD A SUBSEQUENT ARREST OR  
17 JUVENILE PETITION FILED AGAINST HIM OR HER IN THE SAME OR ANOTHER  
18 JUDICIAL DISTRICT WITHIN ONE YEAR; AND

19 (VII) THE NUMBER OF VICTIMS WHO:

20 (A) WERE CONTACTED FOR PARTICIPATION;

21 (B) PARTICIPATED;

22 (C) SUBMITTED VICTIM IMPACT STATEMENTS;

23 (D) SENT A SURROGATE; OR

24 (E) DECLINED TO PARTICIPATE IN A RESTORATIVE JUSTICE  
25 PROGRAM.

26 (c) (I) THE DIVISION OF CRIMINAL JUSTICE SHALL PREPARE A  
27 REPORT BASED ON THE INFORMATION IT RECEIVES PURSUANT TO

1 PARAGRAPH (b) OF THIS SUBSECTION (2) BY DECEMBER 1, 2014.

2 (II) THE DIVISION OF CRIMINAL JUSTICE SHALL PREPARE A REPORT  
3 THAT INCLUDES A SUMMARY OF THE PILOT PROJECT SITES AND THE  
4 EXISTING SITES BASED ON THE INFORMATION IT RECEIVES PURSUANT TO  
5 PARAGRAPH (b) OF THIS SUBSECTION (2) BY DECEMBER 1, 2015.

6 (3) (a) THE PILOT PROJECT AND EXISTING SITES MUST IMPLEMENT  
7 A RESTORATIVE JUSTICE PROGRAM THAT REQUIRES THE DISTRICT  
8 ATTORNEY, PRIOR TO FILING CHARGES, TO ASSESS IF THE JUVENILE IS  
9 SUITABLE FOR PARTICIPATION IN THE RESTORATIVE JUSTICE PILOT  
10 PROGRAM BASED ON THE CONSIDERATIONS SET FORTH IN SECTION  
11 19-2-512 (2). IF THE ASSESSMENT DETERMINES THE JUVENILE IS SUITABLE,  
12 THE DISTRICT ATTORNEY, AFTER CONSULTATION WITH THE VICTIM IN A  
13 VICTIMS' RIGHTS ACT CRIME, MAY OFFER THE JUVENILE PREFILING  
14 DIVERSION TO A PROGRAM UTILIZING RESTORATIVE JUSTICE PRACTICES. IF  
15 THE JUVENILE ACCEPTS PARTICIPATION IN THE PROGRAM UTILIZING  
16 RESTORATIVE JUSTICE PRACTICES, THE DISTRICT ATTORNEY SHALL NOT  
17 FILE THE PETITION. THE DISTRICT ATTORNEY SHALL PLACE THE JUVENILE  
18 IN A DIVERSION PROGRAM UTILIZING RESTORATIVE JUSTICE PRACTICES,  
19 AND THE JUVENILE SHALL PAY A FEE OF ONE HUNDRED TWENTY-FIVE  
20 DOLLARS, BUT THE FEE MAY BE REDUCED ON SLIDING SCALE BASED ON  
21 INCOME CONSISTENT WITH GUIDELINES USED TO DETERMINE ELIGIBILITY  
22 FOR APPOINTMENT OF COUNSEL. IF THE JUVENILE SUCCESSFULLY  
23 COMPLETES THE PROGRAM, THE DISTRICT ATTORNEY SHALL NOT FILE A  
24 PETITION AGAINST THE JUVENILE FOR THE ALLEGED CRIMES THAT LED TO  
25 PARTICIPATION IN THE PROGRAM. IF THE JUVENILE IS CHARGED WITH A  
26 NEW OFFENSE WHILE IN THE PROGRAM OR DOES NOT SUCCESSFULLY  
27 COMPLETE THE PROGRAM UTILIZING RESTORATIVE JUSTICE PRACTICES, THE

1 DISTRICT ATTORNEY MAY INITIATE A PETITION AGAINST THE JUVENILE AND  
2 SHALL PROCEED AS AUTHORIZED IN THIS ARTICLE. ANY STATEMENTS  
3 MADE DURING THE CONFERENCE ARE CONFIDENTIAL AND MAY NOT BE  
4 USED AS A BASIS FOR CHARGING OR PROSECUTING THE DEFENDANT UNLESS  
5 THE DEFENDANT COMMITS A CHARGEABLE OFFENSE DURING THE  
6 CONFERENCE. EACH PARTICIPANT IN THE RESTORATIVE JUSTICE PROGRAM  
7 SHALL COMPLETE THE UNIFORM RESTORATIVE JUSTICE SATISFACTION

15          SURCHARGE FUND CREATED PURSUANT TO SUBSECTION (3) OF THIS  
16          SECTION.

17          (3) (a) THERE IS CREATED IN THE STATE TREASURY THE  
18          RESTORATIVE JUSTICE SURCHARGE FUND THAT CONSISTS OF MONEYS  
19          RECEIVED BY THE STATE TREASURER PURSUANT TO THIS SECTION. THE  
20          MONEYS IN THE FUND ARE SUBJECT TO ANNUAL APPROPRIATION BY THE  
21          GENERAL ASSEMBLY TO THE JUDICIAL DEPARTMENT FOR DISTRIBUTION TO  
22          JUDICIAL DISTRICTS THAT OFFER RESTORATIVE JUSTICE PROGRAMS AND TO  
23          THE RESTORATIVE JUSTICE COORDINATING COUNCIL FOR ADMINISTRATIVE  
24          EXPENSES.

25          (b) THE JUDICIAL DEPARTMENT SHALL ESTABLISH GUIDELINES FOR  
26          THE DISTRIBUTION OF THE MONEYS FROM THE FUND TO ASSIST IN  
27          DEFRAYING THE COSTS OF RESTORATIVE JUSTICE PROGRAMS, INCLUDING

1 BUT NOT LIMITED TO PROCEDURES FOR PROGRAMS TO USE IN APPLYING TO  
2 THE JUDICIAL DEPARTMENT FOR MONEYS FROM THE FUND.

3 (c) THE JUDICIAL DEPARTMENT SHALL NOT EXPEND ANY MONEYS  
4 UNTIL THE FUND HAS ENOUGH MONEY TO PAY THE EXPENSES NECESSARY  
5 TO ADMINISTER THE FUND.

6 (d) ALL INTEREST DERIVED FROM THE DEPOSIT AND INVESTMENT  
7 OF MONEYS IN THE FUND MUST BE CREDITED TO THE FUND. ANY MONEYS  
8 NOT APPROPRIATED BY THE GENERAL ASSEMBLY MUST REMAIN IN THE  
9 FUND AND MAY NOT BE TRANSFERRED OR REVERT TO THE GENERAL FUND

17 (5) AS USED IN THIS SECTION, "CONVICTED" AND "CONVICTION"  
18 MEAN A PLEA OF GUILTY ACCEPTED BY THE COURT, INCLUDING A PLEA OF  
19 GUILTY ENTERED PURSUANT TO A DEFERRED SENTENCE UNDER SECTION  
20 18-1.3-102, A VERDICT OF GUILTY BY A JUDGE OR JURY, OR A PLEA OF NO  
21 CONTEST ACCEPTED BY THE COURT.

22 **SECTION 11.** In Colorado Revised Statutes, 24-4.1-302.5,

7 (g) The availability of restorative justice practices, as defined in  
8 section 18-1-901 (3) (o.5), C.R.S., WHICH INCLUDES VICTIM-OFFENDER  
9 CONFERENCES;

10 **SECTION 13. Appropriation.** (1) In addition to any other  
11 appropriation, there is hereby appropriated, out of any moneys in the  
12 general fund, not otherwise appropriated, to the judicial department, for  
13 the fiscal year beginning July 1, 2013, the sum of \$20,629 and 0.3 FTE,  
14 or so much thereof as may be necessary, to be allocated for the  
15 implementation of this act as follows:

8 referendum petition is filed pursuant to section 1 (3) of article V of the
