1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **amend** 13-1-306 as
3 follows:

4 **13-1-306. Legislative review - repeal.** The underfunded
5 courthouse facility cash fund commission repeals on ~~September 1, 2024~~
6 SEPTEMBER 1, 2035. Prior to repeal, the underfunded courthouse facility
7 cash fund commission is subject to review as provided in section
8 24-34-104. ~~C.R.S.~~

9 **SECTION 2.** In Colorado Revised Statutes, 24-34-104, **repeal**
10 (25)(a)(IX); and **add** (36) as follows:

11 **24-34-104. General assembly review of regulatory agencies**
12 **and functions for repeal, continuation, or reestablishment - legislative**
13 **declaration - repeal.** (25) (a) The following agencies, functions, or both,
14 are scheduled for repeal on September 1, 2024:

15 (IX) ~~The underfunded courthouse facility cash fund commission~~
16 ~~created in part 3 of article 1 of title 13;~~

17 (36) (a) THE FOLLOWING AGENCIES, FUNCTIONS, OR BOTH ARE
18 SCHEDULED FOR REPEAL ON SEPTEMBER 1, 2035:

19 (I) THE UNDERFUNDED COURTHOUSE FACILITY CASH FUND
20 COMMISSION CREATED IN PART 3 OF ARTICLE 1 OF TITLE 13.

21 (b) THIS SUBSECTION (36) IS REPEALED, EFFECTIVE SEPTEMBER 1,

23 **SECTION 3. Act subject to petition - effective date.** This act
24 takes effect at 12:01 a.m. on the day following the expiration of the
25 ninety-day period after final adjournment of the general assembly; except

1 that, if a referendum petition is filed pursuant to section 1 (3) of article V
2 of the state constitution against this act or an item, section, or part of this
3 act within such period, then the act, item, section, or part will not take
4 effect unless approved by the people at the general election to be held in
5 November 2024 and, in such case, will take effect on the date of the
6 official declaration of the vote thereon by the governor.
