3 Section 6. **Appropriation.** (1) In addition to any other
4 appropriation, there is hereby appropriated, out of any moneys in the
5 division of registrations cash fund created in section 24-34-105 (20) (b)
6 (I), Colorado Revised Statutes, not otherwise appropriated, to the
7 department of regulatory agencies, for allocation to the division of
8 registrations, for the establishment of rules to ensure the competency of
9 electricians, for the fiscal year beginning July 1, 2009, the sum of
10 ~~ninety-nine thousand eight hundred ninety-four dollars (\$99,894)~~
11 ninety-six thousand one hundred thirty-nine dollars (\$96,139) cash funds
12 and 1.0 FTE, or so much thereof as may be necessary, for the
13 implementation of this act.

14 (2) In addition to any other appropriation, there is hereby
15 appropriated to the department of law, for the fiscal year beginning July

23 **SECTION 3. Safety clause.** The general assembly hereby finds,
24 determines, and declares that this act is necessary for the immediate
25 preservation of the public peace, health, and safety.
