102	SECTION 21 OF ARTICLE X OF THE STATE CONSTITUTION IN A

Bill Summary

Budget Package Bill. Pursuant to the declaration of a state fiscal emergency, for the 2009-10 fiscal year only, the bill expands the purposes

HOUSE Am ended 2nd Reading February 17, 2010 for which tobacco tax revenues in the health care expansion fund and the health disparities grant program fund may be used to include any health-related purpose and to serve populations enrolled in the children's basic health plan and the Colorado medical assistance program at the programs' respective levels of enrollment as of January 1, 2005.

1 (f) (I) The health disparities grant program fund to be 2 administered by the department of public health and environment. 3 Moneys shall be transferred to the health disparities grant program fund 4 as described in subparagraph (III) of paragraph (d) of this subsection (2). 5 All interest and income derived from the deposit and investment of 6 moneys in the health disparities grant program fund shall be credited to 7 the health disparities grant program fund; except that all interest and 8 income derived from the deposit and investment of moneys in the health 9 disparities grant program fund during the 2008-09, 2009-10, 2010-11, and 10 2011-12 fiscal years shall be credited to the general fund.
