**A BILL FOR AN ACT**

101 **CONCERNING THE PROHIBITION OF INTERNET LOTTERY.**

**Bill Summary**

The bill prohibits the Colorado lottery commission from authorizing an internet lottery in which tickets, games, or shares are sold to a person by means of the internet, telephone, or other electronic device without physical presence of the person at a licensed lottery sales agent's place of business.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-35-201, **amend**  
3 (5); and **add** (4.5) as follows:

4 **24-35-201. Definitions.** As used in this part 2, unless the context  
5 otherwise requires:

6 (4.5) "INTERNET LOTTERY" MEANS ANY LOTTERY AUTHORIZED  
7 AND DESCRIBED IN THE FEDERAL MEMORANDUM OPINION FOR THE  
8 ASSISTANT ATTORNEY GENERAL, CRIMINAL DIVISION, DATED SEPTEMBER  
9 20, 2011, IN THE *OPINIONS OF THE OFFICE OF LEGAL COUNSEL IN VOLUME*  
10 *35*.

11 (5) "Lottery" means any and all lotteries created and operated  
12 pursuant to this part 2, including, without limitation, the game commonly  
13 known as lotto, in which prizes are awarded on the basis of designated  
14 numbers conforming to numbers selected at random, electronically or  
15 otherwise, by or at the direction of the commission, and any multistate  
16 lottery or game that is authorized by a multistate agreement to which the  
17 division is party. All references in this article to "the lottery" shall be  
18 construed to include any or all lotteries within the meaning of this  
19 subsection (5). "Lottery" shall not include a promotional drawing as  
20 defined in subsection (8) of this section. "LOTTERY" SHALL NOT INCLUDE  
21 INTERNET LOTTERY AS DEFINED IN SUBSECTION (4.5) OF THIS SECTION.

22 **SECTION 2.** In Colorado Revised Statutes, 24-35-208, **add** (4)  
23 as follows:

24 **24-35-208. Commission - powers and duties - rules.** (4) THE  
25 COMMISSION SHALL NOT PROMULGATE RULES PURSUANT TO SUBSECTION  
26 (1) OF THIS SECTION AUTHORIZING INTERNET LOTTERY AS DEFINED IN  
27 SECTION 24-35-201 (4.5).

1           **SECTION 3. Safety clause.** The general assembly hereby finds,  
2 determines, and declares that this act is necessary for the immediate  
3 preservation of the public peace, health, and safety.
