101 **CONCERNING REDUCING THE ANNUAL APPROPRIATION FOR**  
102 **PROSECUTION TRAINING.**

**Bill Summary**

**Joint Budget Committee.** The general assembly is required to annually appropriate \$350,000 to the department of law for allocation to the Colorado district attorneys' council for prosecution training. The bill reduces the annual amount to \$200,000 for fiscal year 2020-21.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 20-1-111, **amend**  
3 (4)(b) as follows:

4 **20-1-111. District attorneys may cooperate or contract -**  
5 **contents - appropriation - repeal.** (4) (b) (I) The general assembly shall  
6 annually appropriate three hundred fifty thousand dollars to the  
7 department of law for allocation to the Colorado district attorneys'  
8 council, the statewide organization representing district attorneys, or its  
9 successor, for the public purpose of providing prosecution training,  
10 seminars, continuing education programs, and other prosecution-related  
11 services on behalf of the district attorneys who are members of the  
12 organization, including, but not limited to, costs and expenses for  
13 personnel, administration, materials, and travel.

14 (II) (A) NOTWITHSTANDING THE PROVISIONS OF SUBSECTION  
15 (4)(b)(I) OF THIS SECTION, FOR THE 2020-21 STATE FISCAL YEAR, THE  
16 GENERAL ASSEMBLY SHALL APPROPRIATE TWO HUNDRED THOUSAND  
17 DOLLARS FOR THE PURPOSES DESCRIBED IN SUBSECTION (4)(b)(I) OF THIS  
18 SECTION.

19 (B) THIS SUBSECTION (4)(b)(II) IS REPEALED, EFFECTIVE JULY 1,  
20 2021.

21 **SECTION 2. Appropriation - adjustments to 2020 long bill.** To  
22 implement this act, the general fund appropriation made in the annual  
23 general appropriation act for the 2020-21 state fiscal year to the  
24 department of law for deputy district attorney training is decreased by  
25 \$150,000.

26 **SECTION 3. Safety clause.** The general assembly hereby finds,

- 1 determines, and declares that this act is necessary for the immediate
- 2 preservation of the public peace, health, or safety.
