CONCERNING THE MEMBERSHIP OF THE GOVERNMENT DATA ADVISORY BOARD.

Be it enacted by the General Assembly of the State of Colorado:

SECTION 1. 24-37.5-703 (1) (d) (II), Colorado Revised Statutes, is amended to read:

24-37.5-703. Government data advisory board - created - duties - repeal. (1) (d) (II) Notwithstanding the provisions of subparagraph (I) of this paragraph (d), AT THE INVITATION OF THE CHIEF INFORMATION OFFICER, ADDITIONAL MEMBERS WHO MEET THE QUALIFICATIONS SPECIFIED IN SAID SUBPARAGRAPH (I) MAY BE SELECTED TO PARTICIPATE ON THE ADVISORY BOARD AS FOLLOWS:

(A) The governor, as he or she deems appropriate, may direct the executive director of one or more of the departments that are not specified in said subparagraph (I) OF THIS PARAGRAPH (d) to select a member from his or her department who meets the qualifications specified in said subparagraph (I) to participate on the advisory board at the invitation of the

- (B) THE SECRETARY OF STATE, ATTORNEY GENERAL, AND STATE TREASURER, AS HE OR SHE DEEMS APPROPRIATE, MAY SELECT A MEMBER FROM HIS OR HER DEPARTMENT;
- (C) THE CHIEF JUSTICE OF THE SUPREME COURT, AS HE OR SHE DEEMS APPROPRIATE, MAY SELECT A MEMBER FROM THE JUDICIAL BRANCH; AND
- (D) THE SPEAKER OF THE HOUSE OF REPRESENTATIVES AND THE PRESIDENT OF THE SENATE MAY JOINTLY SELECT A MEMBER FROM THE LEGISLATIVE BRANCH, INCLUDING A REPRESENTATIVE, SENATOR, OR EMPLOYEE.

SECTION 2. Safety clause. The general assembly hereby finds,
