CONCERNING A THIRD-PARTY EVALUATION OF THE DEPARTMENT OF CORRECTIONS' BUDGET PRACTICES, AND, IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.

Be it enacted by the General Assembly of the State of Colorado:

SECTION 1. In Colorado Revised Statutes, **add 2-3-130** as follows:

2-3-130. Audit - department of corrections - budget practices - third-party auditor. AS SOON AS PRACTICABLE, BUT NO LATER THAN OCTOBER 1, 2024, THE STATE AUDITOR SHALL ENGAGE A THIRD-PARTY CONSULTANT TO CONDUCT AN EVALUATION OF THE DEPARTMENT OF CORRECTIONS, CREATED IN SECTION 24-1-128.5. IN PARTNERSHIP WITH THE

DEPARTMENT OF CORRECTIONS, THE EVALUATION MUST EXAMINE THE DEPARTMENT OF CORRECTIONS' BUDGET PRACTICES, INCLUDING PERSONNEL-RELATED COSTS, CONTRACT STAFF SPENDING, CONTRACT AGENCY STAFF COSTS, FINANCIAL IMPACT OF STAFF VACANCIES ON THE AVAILABILITY AND OUTCOMES OF REHABILITATIVE PROGRAMMING AND SEX OFFENDER TREATMENT, THE CHANGE IN INMATE PAY SINCE JULY 1, 2014, GROWTH AND UTILIZATION OF HOUSING AND CASH ASSISTANCE SINCE JULY 1, 2014, OPERATIONAL COSTS DRIVEN BY CASELOAD, USER FEES LEVIED, AND THE CASH FUNDS ASSOCIATED WITH THE DEPARTMENT OF CORRECTIONS. THE THIRD-PARTY CONSULTANT SHALL MAKE RECOMMENDATIONS TO THE DEPARTMENT OF CORRECTIONS THROUGHOUT THE EVALUATION AND UPDATE THE JOINT BUDGET COMMITTEE AND LEGISLATIVE AUDIT COMMITTEE WITH PRELIMINARY FINDINGS AND RECOMMENDATIONS BY MARCH 1, 2025. THE THIRD-PARTY CONSULTANT SHALL REPORT ITS FINAL FINDINGS AND RECOMMENDATIONS TO THE DEPARTMENT, THE JOINT BUDGET COMMITTEE, AND THE LEGISLATIVE AUDIT COMMITTEE BY JUNE 30, 2025.

SECTION 2. Appropriation. For the 2024-25 state fiscal year, \$400,000 is appropriated to the legislative department for use by the office of the state auditor. This appropriation is from the general fund. The office may use this appropriation to implement this act.

SECTION 3. Safety clause. The general assembly finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, or safety or for appropriations for

the support and maintenance of the departments of the state and state institutions.
