A BILL FOR AN ACT

101	CONCERNING THE REPEAL OF THE REQUIREMENT THAT THE GENERAL
102	ASSEMBLY ANNUALLY PASS A JOINT RESOLUTION TO CERTIFY A
103	GENERAL FUND REVENUE ESTIMATE.

Bill Summary

The bill repeals the requirement that the general assembly annually pass a joint resolution by February 1 to certify to the state controller the general fund revenue estimate for the next state fiscal year.

SENATE 3rd Reading Unamended January 24, 2013

1	Be it enacted by the General Assembly of the State of Colorado:
2	SECTION 1. In Colorado Revised Statutes, amend 24-75-201.3
3	as follows:
4	24-75-201.3. Procedures relating to revenue estimates. (1) The
5	general assembly, acting by joint resolution, shall certify to the controller
6	by February 1 of each year for the purpose of determining the amount of
7	general funds available for appropriation the revenue estimate for the next
8	fiscal year of the state, which estimate shall be certified after taking into
9	consideration the estimates of the office of state planning and budgeting
10	and the staff of the legislative council.
11	(2) No later than June 20 prior to the beginning of each fiscal
12	year, and no later than September 20, December 20, and March 20 within
13	each fiscal year, the governor, with the assistance of the controller, the
14	office of state planning and budgeting, and the governor's
15	revenue-estimating advisory group, shall make an estimate of general
16	fund revenues for such fiscal year. Copies of each such revenue estimate
17	shall MUST be promptly transmitted to the general assembly. Such revenue
18	estimates shall be ARE used in the implementation of section 24-75-201.5
19	but shall ARE not be binding on the general assembly in determining the
20	amount of general funds available for appropriation for the next ensuing
21	fiscal year. pursuant to subsection (1) of this section.
22	SECTION 2. In Colorado Revised Statutes, 39-22-2003, amend
23	(4) (b) as follows:
24	39-22-2003. State sales tax refund - offset against state income
25	tax - qualified individuals. (4) (b) In calculating income classifications
26	or the amount of refund allowed for a given income classification in

 use the most recent estimate of general fund revenues for the applicable
 taxable year prepared by the staff of the legislative council of the general
 assembly. in accordance with section 24-75-201.3, C.R.S.
