A BILL FOR AN ACT

101 **CONCERNING THE INCLUSION OF CERTAIN LAND AREAS USED TO GROW**
102 **PRODUCTS THAT ORIGINATE ABOVE THE GROUND WITHIN THE**
103 **CLASSIFICATION OF "ALL OTHER AGRICULTURAL PROPERTY"**
104 **FOR PROPERTY TAX PURPOSES.**

other horticultural or agricultural production areas used to grow food products or horticultural stock that originate above the ground. The bill directs the county assessor to assess such property using the market value of agricultural land by acre in the county in which the property is located.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 39-1-102, **amend**
3 (1.6) (b) as follows:

4 **39-1-102. Definitions.** As used in articles 1 to 13 of this title,
5 unless the context otherwise requires:

6 (1.6) (b) (I) EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS
7 PARAGRAPH (b), all other agricultural property that does not meet the
8 definition set forth in paragraph (a) of this subsection (1.6) shall be
9 classified as all other property and shall be valued using appropriate
10 consideration of the three approaches to appraisal based on its actual use
11 on the assessment date.

12 (II) ON AND AFTER JANUARY 1, 2015, "ALL OTHER AGRICULTURAL
13 PROPERTY" INCLUDES GREENHOUSE AND NURSERY PRODUCTION AREAS
14 USED TO GROW FOOD PRODUCTS, AGRICULTURAL PRODUCTS, OR
15 HORTICULTURAL STOCK FOR WHOLESALE PURPOSES ONLY THAT ORIGINATE
16 ABOVE THE GROUND.

17 **SECTION 2. Act subject to petition - effective date.** This act takes
18 effect at 12:01 a.m. on the day following the expiration of the
19 ninety-day period after final adjournment of the general assembly
20 (August 6, 2014, if adjournment sine die is on May 7, 2014); except
21 that, if a referendum petition is filed pursuant to section 1 (3) of article
22 V of the state constitution against this act or an item, section, or part of
23 this act within such period, then the act, item, section, or part will not

1 take effect unless approved by the people at the general election to be
2 held in November 2014 and, in such case, will take effect on the date
3 of the official declaration of the vote thereon by the governor. March 6,
