A BILL FOR AN ACT

101 CONCERNING THE FACILITATION OF ASPHALT SHINGLE RECYCLING.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://leg.colorado.gov.)

The bill specifies that asphalt shingles may be transported and stored in railroad cars pending delivery for recycling and pending recycling at a recycling facility and stored outside pending delivery for recycling and may be stored outside of a recycling facility pending recycling.

1	Be it enacted by the General Assembly of the State of Colorado:
2	SECTION 1. In Colorado Revised Statutes, 30-20-102, amend
3	(5) as follows:
4	30-20-102. Unlawful to operate site and facility without
5	certificate of designation - rules - exceptions. (5) (a) Any site and
6	facility operated for the purpose of processing, reclaiming, or recycling
7	recyclable materials shall not be considered a solid wastes disposal site
8	and facility and shall DOES not require a certificate of designation as a
9	solid wastes disposal site and facility; except that, after an initial
10	accumulation period specified by rule, such a site or facility shall
11	maintain documentation that proves recyclable materials are being
12	recycled at the site at a rate that approximately equals the rate at which
13	recyclable materials are being collected.
14	(b) The solid and hazardous waste commission shall promulgate
15	rules:
16	(I) To specify what time periods and volumes of recyclable
17	materials constitute operations that qualify for this exemption; and
18	(II) To define what materials shall be deemed to be recyclable
19	materials for the purposes of this subsection (5); except that such THE
20	rules shall MUST not define the term "recyclable materials" to EXCLUDE
21	ASPHALT SHINGLES OR include materials that are likely to contaminate
22	groundwater or create off-site odors as a result of processing, reclaiming
23	recycling, or storage prior to recycling.
24	(c) ASPHALT SHINGLES MAY BE TRANSPORTED AND STORED IN
25	RAILROAD CARS PENDING DELIVERY FOR RECYCLING AND PENDING
26	RECYCLING AT A RECYCLING FACILITY AND STORED OUTSIDE PENDING
27	DELIVERY FOR RECYCLING AND MAY BE STORED OUTSIDE OF A RECYCLING

2	(d) This subsection (5) does not apply to activities regulated under
3	section 25-8-205 (1)(e). C.R.S.
4	SECTION 2. Applicability. This act applies to conduct occurring
5	on or after the effective date of this act.
6	SECTION 3. Safety clause. The general assembly hereby finds
7	determines, and declares that this act is necessary for the immediate
8	preservation of the public peace, health, or safety.
