Bill Summary

The bill permits a fermented malt beverage retailer that is licensed to sell fermented malt beverages for off-premises consumption and that

has licensed premises comprising less than 7,500 square feet to use a third-party delivery service, instead of its own employees and vehicles, to deliver fermented malt beverages to its customers.

1 Be it enacted by the General Assembly of the State of Colorado: 2 **SECTION 1.** In Colorado Revised Statutes, 44-4-107, amend 3 (6)(a)(II) and (6)(b) as follows: 4 44-4-107. Local licensing authority - application - fees -5 **definitions - rules - repeal.** (6) (a) A person licensed under subsection 6 (1)(a) of this section who complies with this subsection (6) and rules 7 promulgated under this subsection (6) may deliver fermented malt 8 beverages in sealed containers to a person of legal age if: 9 (II) The delivery is made by an employee of the fermented malt 10 beverage retailer who is at least twenty-one years of age and who is using 11 a vehicle owned or leased by the licensee to make the delivery; EXCEPT 12 THAT A FERMENTED MALT BEVERAGE RETAILER WITH LICENSED PREMISES 13 COMPRISING LESS THAN SEVEN THOUSAND FIVE HUNDRED SQUARE FEET OF 14 TOTAL RETAIL SPACE MAY USE A THIRD-PARTY DELIVERY SERVICE TO 15 MAKE DELIVERIES OF FERMENTED MALT BEVERAGES PURSUANT TO THIS 16 SUBSECTION (6) AS LONG AT THE PERSON MAKING THE DELIVERY IS AT 17 LEAST TWENTY-ONE YEARS OF AGE; 18 The state licensing authority shall promulgate rules as 19 necessary for the proper delivery of fermented malt beverages pursuant 20 to this subsection (6) and may issue a permit to any person who THAT is 21 licensed pursuant to SUBSECTION (1)(a) OF THIS SECTION and THAT 22 delivers fermented malt beverages under subsection (1)(a) of this section 23 PURSUANT TO THIS SUBSECTION (6). A permit issued under this subsection (6) is subject to the same suspension and revocation provisions as are set 24

forth in section 44-3-601 for other licenses granted pursuant to article 3 of this title 44.

SECTION 2. Act subject to petition - effective date. This act takes effect at 12:01 a.m. on the day following the expiration of the ninety-day period after final adjournment of the general assembly; except that, if a referendum petition is filed pursuant to section 1 (3) of article V of the state constitution against this act or an item, section, or part of this act within such period, then the act, item, section, or part will not take effect unless approved by the people at the general election to be held in November 2022 and, in such case, will take effect on the date of the official declaration of the vote thereon by the governor.
