Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. In order to qualify to serve on the board of examiners of nursing home administrators (board), current law requires nursing home administrator (NHA) members to be engaged in particular areas of discipline in the profession and to have been actively engaged in the profession for at least 5 years. **Section 1** of the bill eliminates the requirement that NHAs practice in a specific discipline area in order to serve on the board. **Section 2** reduces the period during which an NHA must be engaged in the profession to 3 years.

An NHA applying to take the NHA licensure examination must have either successfully completed the administrator-in-training (AIT) program; completed a bachelor's degree in public health administration; or completed an associate's degree in a health care-related field and have at least 2 years experience in administration in a nursing home or hospital. Under board rules, to satisfy the experience-in-administration component, an applicant must be supervising and exercising reasonable control over at least 5 subordinates. **Section 3** reduces the number of subordinates that an applicant must supervise to 3 subordinates and reduces the required amount of experience from 2 years to one year. Section 3 also requires the board to allow an NHA who has passed both a national NHA examination and an examination in another state to take the Colorado licensure examination.

Finally, current law requires an AIT program participant to complete 2,000 hours of training before he or she is eligible to take the NHA licensure examination. **Section 4** reduces the required training period to 500 hours.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 12-39-104, **amend**

3 (1) (a) introductory portion, (1) (a) (I), and (2) as follows:

4 **12-39-104. Board of examiners of nursing home**
5 **administrators - creation - subject to termination.** (1) (a) ~~There is~~

1 ~~hereby created a~~ THE board of examiners of nursing home administrators
2 IS HEREBY CREATED in the division of registrations in the department of
3 regulatory agencies. ~~which~~ THE board ~~shall be~~ IS composed of the
4 following members appointed by the governor:

5 (I) Three members ~~shall be~~ WHO ARE practicing nursing home
6 administrators duly licensed under this article, and AT LEAST ONE OF
7 WHOM shall be from the following areas of discipline, with no two
8 members from the same area:

9 (A) ~~Hospital administration;~~

10 (B) nonprofit facility administration.

11 (C) ~~Proprietary facility administration; or~~

12 (D) ~~Continuum of care administration;~~

13 (2) (a) THE GOVERNOR SHALL MAKE appointments to the board.
14 ~~shall be made by the governor~~ IN MAKING AN APPOINTMENT TO FILL A
15 VACANCY ON THE BOARD IN THE POSITION OF, OR TO FILL THE REMAINDER
16 OF AN UNEXPIRED TERM FOR, A NURSING HOME ADMINISTRATOR WHO IS
17 FROM NONPROFIT FACILITY ADMINISTRATION, AS REQUIRED BY
18 SUBPARAGRAPH (I) OF PARAGRAPH (a) OF SUBSECTION (1) OF THIS
19 SECTION, IF THE GOVERNOR, AFTER A GOOD-FAITH ATTEMPT, IS UNABLE TO
20 FIND A NURSING HOME ADMINISTRATOR CANDIDATE WHO COMES FROM
21 NONPROFIT FACILITY ADMINISTRATION TO FILL THE VACANCY OR
22 COMPLETE THE UNEXPIRED TERM, THE GOVERNOR MAY APPOINT ANY
23 QUALIFIED NURSING HOME ADMINISTRATOR TO COMPLETE THE UNEXPIRED
24 TERM OR FILL THE VACANCY IN THAT BOARD POSITION. IF THE
25 APPOINTMENT IS TO FILL A VACANCY, THE BOARD MEMBER MAY SERVE
26 THE FULL TERM AND IS ELIGIBLE FOR APPOINTMENT FOR A SECOND TERM.

27 (b) The governor may remove any board member for negligence,

1 incompetency, unprofessional conduct, or willful misconduct. Actions
2 constituting neglect of duty shall include but ARE not be limited to three
3 unexcused absences from scheduled meetings in any one calendar year.
4 ~~Appointments to fill vacancies shall be made~~ THE GOVERNOR SHALL FILL
5 A VACANCY IN THE MEMBERSHIP OF THE BOARD for the remainder of the
6 unexpired term. A member who is a practicing nursing home
7 administrator or long-term care professional shall serve for a full term
8 only if, during such term, such member is actively employed as a
9 practicing member of his or her profession without a lapse of employment
10 greater than one hundred twenty days.

11 **SECTION 2.** In Colorado Revised Statutes, 12-39-104.5, **amend**
12 (1) as follows:

13 **12-39-104.5. Qualifications of board members.** (1) A nursing
14 home administrator shall be IS qualified to be appointed to the board if
15 such THE person:

- 16 (a) Is a legal resident of Colorado;
- 17 (b) Is currently licensed as a nursing home administrator; AND
- 18 (c) Has been actively engaged as a licensed nursing home
19 administrator for at least ~~five~~ THREE years.

20 **SECTION 3.** In Colorado Revised Statutes, 12-39-106, **amend**
21 (1) as follows:

22 **12-39-106. Qualifications for admission to examination.**

23 (1) The board shall admit to examination for licensure as a nursing home
24 administrator any applicant who pays a fee as determined by the board,
25 who submits evidence of suitability prescribed by the board, who is
26 twenty-one years of age or older, and who provides written
27 documentation that the applicant meets one of the following

1 requirements:

2 (a) The applicant has successfully completed the
3 administrator-in-training program pursuant to section 12-39-107; or

4 (b) The applicant has successfully completed a bachelor's degree
5 OR HIGHER DEGREE in public health administration OR health
6 administration, A MASTER'S DEGREE IN MANAGEMENT OR BUSINESS
7 ADMINISTRATION, or any degree or degrees deemed appropriate by the
8 board; or

9 (c) (I) The applicant has successfully completed an associate's
10 degree or higher degree in a health care-related field OR A BACHELOR'S
11 DEGREE IN BUSINESS OR PUBLIC ADMINISTRATION and has a minimum of
12 ~~two years~~ ONE YEAR OF experience in administration in a nursing home
13 or hospital. For the purposes of this section, a registered nurse who is a
14 graduate of a three-year diploma program ~~shall be considered to have met~~
15 MEETS the associate degree requirement.

16 (II) FOR PURPOSES OF THE EXPERIENCE REQUIRED BY THIS
17 PARAGRAPH (c), AN APPLICANT MUST HAVE DAY-TO-DAY, ON-SITE
18 RESPONSIBILITY FOR SUPERVISING, DIRECTING, MANAGING, MONITORING,
19 OR EXERCISING REASONABLE CONTROL OVER SUBORDINATES FOR ONE
20 YEAR.

22 **SECTION 4.** In Colorado Revised Statutes, 12-39-107, **amend**
23 (1) as follows:

24 **12-39-107. Administrator-in-training.** (1) THE BOARD MAY
25 GRANT ADMISSION INTO THE NURSING HOME ADMINISTRATOR-IN-TRAINING
26 PROGRAM TO an applicant for a nursing home administrator's license who
27 meets the board's criteria for education and experience, pursuant to

1 section 12-39-107.5. ~~may be granted admission into the nursing home~~
2 ~~administrator-in-training program.~~ Upon successful completion of the
3 ~~two-thousand-hour~~ ONE-THOUSAND-HOUR training period, ~~said~~ THE
4 applicant ~~shall be~~ IS eligible to take the examination.

5 **SECTION 5.** In Colorado Revised Statutes, 12-39-110, **amend**
6 **(1) as follows:**

7 **12-39-110. Endorsement. (1) (a)** The board shall issue a license
8 to any person duly licensed to practice nursing home administration in
9 another state or territory of the United States ~~who possesses credentials~~
10 and qualifications which are substantially equivalent to the requirements
11 of section 12-39-106 and who:

12 (I) PROVIDES WRITTEN DOCUMENTATION VERIFYING THAT THE
13 APPLICANT HAS PASSED A NATIONAL EXAMINATION ADMINISTERED BY A
14 NATIONALLY RECOGNIZED TESTING ENTITY FOR NURSING HOME
15 ADMINISTRATORS AND HAS PASSED AN EXAMINATION IN ANOTHER STATE;
16 AND

17 (II) Successfully completes the Colorado state examination
18 provided in section 12-39-109.

19 (b) For purposes of this section, "state or territory" includes the
20 District of Columbia and the commonwealth of Puerto Rico.

21 **SECTION 6. No appropriation.** The general assembly has
22 determined that this act can be implemented within existing
23 appropriations, and therefore no separate appropriation of state moneys
24 is necessary to carry out the purposes of this act.

25 **SECTION 7. Act subject to petition - effective date.** This act
26 takes effect September 1, 2012; except that, if a referendum petition is
27 filed pursuant to section 1 (3) of article V of the state constitution against

1 this act or an item, section, or part of this act within the ninety-day period
2 after final adjournment of the general assembly, then the act, item,
3 section, or part will not take effect unless approved by the people at the
4 general election to be held in November 2012 and, in such case, will take
5 effect on the date of the official declaration of the vote thereon by the
6 governor.
