## A BILL FOR AN ACT

CONCERNING CRIMINALIZING UNLAWFULLY POINTING A LASER DEVICE

102 AT AN AIRCRAFT.

### **Bill Summary**

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill creates a class 6 felony for a person who knowingly points, focuses, or aims a laser device at an aircraft.

The bill provides exemptions for a person who points a laser device at an aircraft under certain circumstances.

8	OR A CREW MEMBER OF THE IMPACTED AIRCRAFT TO A LAW ENFORCEMENT
9	OFFICER OR LAW ENFORCEMENT AGENCY, COMMITS THE OFFENSE OF
10	UNLAWFULLY AIMING A LASER DEVICE AT AN AIRCRAFT, WHICH IS A CLASS
11	6 FELONY.
12	(2) THE OFFENSE DESCRIBED IN SUBSECTION (1) OF THIS SECTION
13	DOES NOT APPLY IF THE PERSON:
14	(a) IS AN AUTHORIZED INDIVIDUAL CONDUCTING RESEARCH AND
15	DEVELOPMENT OR FLIGHT TEST OPERATIONS FOR AN AIRCRAFT
16	MANUFACTURER OR THE FEDERAL AVIATION ADMINISTRATION, OR ANY
17	OTHER PERSON AUTHORIZED BY THE FEDERAL AVIATION ADMINISTRATION
18	TO CONDUCT RESEARCH AND DEVELOPMENT OR FLIGHT TEST OPERATIONS;
19	(b) Is a member of the United States department of defense
20	OR THE UNITED STATES DEPARTMENT OF HOMELAND SECURITY ACTING IN
21	AN OFFICIAL CAPACITY FOR THE PURPOSE OF RESEARCH, DEVELOPMENT,
22	OPERATIONS, TESTING, OR TRAINING; OR
23	(c) Uses a laser device with the intent of sending an
24	EMERGENCY DISTRESS SIGNAL.
25	(3) As used in this section, unless the context otherwise
26	REQUIRES:
27	(a) "AIRCRAFT" MEANS A DEVICE MANNED BY A PERSON THAT IS

1	USED OR INTENDED TO BE USED FOR FLIGHT IN THE AIR.
2	(b) "LASER DEVICE" MEANS ANY DEVICE DESIGNED OR USED TO
3	AMPLIFY ELECTROMAGNETIC RADIATION BY STIMULATED EMISSION THAT
4	EMITS A BEAM IN THE ULTRAVIOLET, VISIBLE, OR INFRARED REGION OF THE
5	SPECTRUM.
6	SECTION 2. Effective date - applicability. This act takes effect
7	July 1, 2023, and applies to offenses committed on or after said date.
8	SECTION 3. Safety clause. The general assembly hereby finds
9	determines, and declares that this act is necessary for the immediate
10	preservation of the public peace, health, or safety.
