sunset review and report on the regulation of pesticide applicators by the department of agriculture by:

- ! Extending the repeal date of the regulatory program until September 1, 2024 (**sections 1 and 2** of the bill);
- ! Adding a representative of the agricultural sector affected by the federal pesticide worker protection standard and a representative of organic farmers to the pesticide advisory committee (**section 3**);
- ! Reducing the period for which private applicators must maintain records from 3 years to 2 years in keeping with applicable federal requirements (**section 4**); and
- ! Measuring the deadline for licensing applications by when the application is received rather than by when it is postmarked (**sections 5 and 6**).

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-34-104, **repeal**  
3 (46) (i); and **add** (53.5) (h) as follows:

4 **24-34-104. General assembly review of regulatory agencies**  
5 **and functions for termination, continuation, or reestablishment.**

6 (46) The following agencies, functions, or both shall terminate on July  
7 1, 2015:

8 (i) ~~The regulation of commercial applicators, qualified~~  
9 ~~supervisors, certified operators, and private applicators by the~~  
10 ~~commissioner of agriculture in accordance with article 10 of title 35,~~  
11 ~~C.R.S.;~~

12 (53.5) The following agencies, functions, or both, terminate on  
13 September 1, 2022:

14 (h) THE REGULATION BY THE COMMISSIONER OF AGRICULTURE OF  
15 THE APPLICATION OF PESTICIDES PURSUANT TO ARTICLE 10 OF TITLE 35,  
16 C.R.S.

17 **SECTION 2.** In Colorado Revised Statutes, **amend** 35-10-128 as

1 follows:

2 **35-10-128. Repeal of article - termination of functions.**

3 Effective ~~July 1, 2015~~ SEPTEMBER 1, 2022, this article is repealed. ~~The~~  
4 ~~regulatory functions of the commissioner of agriculture shall also~~  
5 ~~terminate on July 1, 2015.~~ Prior to such THE repeal, ~~and termination, the~~  
6 ~~regulatory functions shall be reviewed~~ THE DEPARTMENT OF REGULATORY  
7 AGENCIES SHALL REVIEW THE REGULATION BY THE COMMISSIONER OF THE  
8 APPLICATION OF PESTICIDES PURSUANT TO THIS ARTICLE as provided for  
9 in section 24-34-104, C.R.S., and ~~as part of such review, the department~~  
10 ~~of regulatory agencies~~ shall report on the extent of local regulation of  
11 pesticides pursuant to section 31-15-707 (1) (b), C.R.S., or under the  
12 police power of any political subdivision of the state.

14 **SECTION 3.** In Colorado Revised Statutes, **amend** 35-10-111 as  
15 follows:

16 **35-10-111. Record-keeping requirements.** (1) Each  
17 commercial, registered limited commercial, licensed private, and  
18 registered public applicator shall keep and maintain records of each  
19 pesticide application in the form and manner designated by the  
20 commissioner. ~~Such~~ THE APPLICATOR SHALL RETAIN THE records ~~shall be~~  
21 ~~retained~~ for a ~~period~~ of three years after the date of the pesticide  
22 application; ~~and~~ EXCEPT THAT THE RECORD RETENTION PERIOD FOR  
23 PRIVATE APPLICATORS IS TWO YEARS.

24 (2) THE RECORDS shall be kept AS FOLLOWS:

25 (a) FOR A COMMERCIAL APPLICATOR, at the address specified in  
26 the application for the commercial applicator's business license; ~~or, in the~~  
27 ~~case of~~

1 (b) FOR A registered limited commercial ~~and~~ OR registered public  
2 ~~applicators~~ APPLICATOR, at the address specified in the registry authorized  
3 in section 35-10-109; or ~~in the case of~~

4 (c) FOR A licensed private ~~applicators~~, APPLICATOR, at the address  
5 of record on file with the commissioner.

6 **SECTION 4.** In Colorado Revised Statutes, 35-10-107, **amend**  
7 (2) and (3) as follows:

8 **35-10-107. Commercial applicator business license - renewals.**

9 (2) If the application for renewal is not ~~postmarked~~ RECEIVED on or  
10 before the expiration date of the license, a penalty fee of ten percent of  
11 the renewal fee shall be assessed and added to the renewal fee. No license  
12 shall be renewed until the total fee is paid.

13 (3) If the application and fee for renewal are not ~~postmarked~~  
14 RECEIVED on or before the thirtieth day following the expiration date of  
15 the license, the business license shall not be renewed, and the commercial  
16 applicator shall apply for a new license.

17 **SECTION 5.** In Colorado Revised Statutes, 35-10-116, **amend**  
18 (5) as follows:

19 **35-10-116. Qualified supervisor and certified operator licenses**

20 **- expiration - renewal of licenses - reinstatement.** (5) If the application  
21 and fee for renewal of any license issued pursuant to section 35-10-115  
22 are not ~~postmarked~~ RECEIVED on or before the thirtieth day following the  
23 expiration date of the license, the license shall not be renewed and the  
24 licensee shall apply for a new license.

25 **SECTION 6.** In Colorado Revised Statutes, **amend** 35-10-109 as  
26 follows:

27 **35-10-109. Limited commercial and public applicators - no**

1 **business license required - training -rules.** (1) ~~No~~ A business license  
2 ~~shall be~~ IS NOT required for limited commercial or public applicators;  
3 except that the commissioner shall require such applicators that apply  
4 restricted-use pesticides to register with the department. The  
5 commissioner shall determine the form and manner of the registration, as  
6 well as the amount of any administrative fees associated with ~~such~~ THE  
7 registration. A limited commercial or public applicator may register  
8 voluntarily, regardless of whether ~~such~~ THE applicator applies  
9 restricted-use pesticides, by submitting a request in the form and manner  
10 specified by the commissioner.

11 (2) (a) A PUBLIC APPLICATOR SHALL NOT ALLOW A PERSON  
12 WORKING FOR IT TO APPLY A GENERAL-USE PESTICIDE THAT HAS BEEN  
13 LISTED BY THE COMMISSIONER BY RULE UNLESS THE PERSON HAS BEEN  
14 TRAINED IN THE CORE ELEMENTS OF PESTICIDE USE AS REQUIRED BY THE  
15 COMMISSIONER BY RULE. THE PUBLIC APPLICATOR SHALL MAINTAIN A  
16 RECORD OF THE TRAINING AS SPECIFIED BY THE COMMISSIONER BY RULE.

17 (b) THE OWNER OR DESIGNEE OF A LIMITED COMMERCIAL  
18 APPLICATOR MUST BE TRAINED IN THE CORE ELEMENTS OF PESTICIDE USE  
19 AS REQUIRED BY THE COMMISSIONER BY RULE BEFORE APPLYING A  
20 GENERAL-USE PESTICIDE THAT HAS BEEN LISTED BY THE COMMISSIONER  
21 BY RULE. THE LIMITED COMMERCIAL APPLICATOR SHALL MAINTAIN A  
22 RECORD OF THE TRAINING AS SPECIFIED BY THE COMMISSIONER BY RULE.

23 **SECTION 7.** In Colorado Revised Statutes, **amend** 35-10-124 as  
24 follows:

25 **35-10-124. Information.** (1) The commissioner, in cooperation  
26 with other agencies of this state or the federal government, may publish  
27 information pertaining to the use and handling of pesticides and conduct

1 workshops for the purpose of informing the pesticide applicators of new  
2 developments in the field of pesticides.

3 (2) THE COMMISSIONER SHALL PROVIDE INTERNET ACCESS TO  
4 FINALIZED ENFORCEMENT ACTION INFORMATION TO THE GENERAL PUBLIC  
5 CONSISTING OF, AT A MINIMUM, THE NAME OF THE VIOLATOR, DATE OF THE  
6 ACTION, CITY OR COUNTY IN WHICH THE VIOLATION OCCURRED, NEAREST  
7 MAJOR INTERSECTION OF ROADS TO WHERE THE VIOLATION OCCURRED,  
8 AND FINAL ENFORCEMENT DISPOSITION. THE COMMISSIONER SHALL  
9 PUBLISH THE INFORMATION IN A FORM AND MANNER DESIGNATED BY THE  
10 COMMISSIONER WITHIN THIRTY DAYS AFTER THE FINAL DISPOSITION.

11 **SECTION 8.** In Colorado Revised Statutes, 35-10-125, **amend**  
12 (1), (2) introductory portion, (2) (f), (2) (h), and (2) (i); and **add** (2) (j),  
13 (2) (k), and (2) (l) as follows:

14 **35-10-125. Advisory committee - sunset review.** (1) The state  
15 agricultural commission created by section 35-1-105 shall appoint an  
16 advisory committee of ~~eleven~~ FIFTEEN members to ADVISE THE  
17 COMMISSIONER ON AGRICULTURAL, HUMAN HEALTH, ENVIRONMENTAL,  
18 WILDLIFE, WORKER SAFETY, AND OTHER MATTERS REGARDING THE USE OF  
19 PESTICIDES IN COLORADO AND TO assist the commissioner in  
20 promulgating rules ~~and regulations~~ to carry out ~~the provisions of this~~  
21 article.

22 (2) The committee ~~shall consist~~ IS A STATE PUBLIC BODY, AS THAT  
23 TERM IS DEFINED IN SECTION 24-6-402 (1) (d), C.R.S., AND CONSISTS OF  
24 the following members:

25 (f) Two representatives from public applicators registered under  
26 this article, each of whom ~~shall~~ MUST be an elected official or a designee  
27 thereof, AND AT LEAST ONE OF WHOM MUST BE TRAINED IN INTEGRATED

- 1 PEST MANAGEMENT;
- 2 (h) ~~A representative~~ TWO REPRESENTATIVES from the Colorado  
3 department of public health and environment, ~~and~~ BOTH OF WHOM HAVE  
4 EXPERTISE IN EITHER:
- 5 (I) HUMAN HEALTH WITH RESPECT TO TOXICOLOGY, PEST-RELATED  
6 DISEASE VECTORS, AND EPIDEMIOLOGY;
- 7 (II) HAZARDOUS MATERIALS AND FOOD SAFETY;
- 8 (III) AIR POLLUTION AND HAZARDOUS PESTICIDE AIR POLLUTANTS;
- 9 OR
- 10 (IV) WATER POLLUTION AND AGRICULTURAL ACTIVITIES;
- 11 (i) Two representatives from the general public, one of whom is  
12 actively engaged in URBAN agricultural production;
- 13 (j) A MEMBER OF A STATE OR NATIONAL APIARY OR BEEKEEPER  
14 ASSOCIATION WHO IS CURRENTLY ACTIVE IN APIARY MANAGEMENT AND  
15 WHO IS EITHER AN ELECTED OFFICIAL OF OR A DESIGNEE OF THE  
16 ASSOCIATION;
- 17 (k) A REPRESENTATIVE FROM THE AGRICULTURAL SECTOR WHO IS  
18 A WORKER, AS THAT TERM IS DEFINED IN 40 CFR 170.3; AND
- 19 (l) A REPRESENTATIVE FROM THE AGRICULTURAL SECTOR WHO IS  
20 ACTIVELY ENGAGED IN ORGANIC AGRICULTURAL PRODUCTION.

21 **SECTION 9. Applicability.** This act applies to conduct occurring  
22 on or after July 1, 2015.

23 **SECTION 10. Safety clause.** The general assembly hereby finds,  
24 determines, and declares that this act is necessary for the immediate  
25 preservation of the public peace, health, and safety.
