A BILL FOR AN ACT

101 **CONCERNING COMPENSATION OF MEMBERS OF THE GENERAL**
102 **ASSEMBLY APPOINTED TO AND SERVING ON STATE ENTITIES,**
103 **AND, IN CONNECTION THEREWITH, MAKING AND REDUCING**
104 **APPROPRIATIONS.**

who are appointed to serve on state entities created or authorized by statute on which members of the general assembly are statutorily required to be appointed to serve. When the general assembly is in session and legislative members attend meetings of a state entity to which they are appointed, legislative members will only receive the per diem lodging and expense allowances and travel expenses that they receive as legislative members. When the general assembly is not in session or is in recess for more than 3 days and legislative members attend meetings of a state entity to which they are appointed, legislative members will receive the same per diem and travel and subsistence expenses received by legislative members for necessary attendance at meetings or functions or to legislative matters during the legislative recess or interim.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add** 2-2-326 as
3 follows:

4 **2-2-326. Compensation and expenses for members appointed**
5 **to and serving on state entities - definition.** (1) NOTWITHSTANDING
6 ANY LAW TO THE CONTRARY:

7 (a) WHILE APPOINTED TO ANY STATE ENTITY AND SERVING ON ANY
8 STATE ENTITY DURING REGULAR AND SPECIAL SESSIONS OF THE GENERAL
9 ASSEMBLY, IN ADDITION TO THE BASE COMPENSATION SPECIFIED IN
10 SECTION 2-2-307 (1), CURRENT MEMBERS OF THE GENERAL ASSEMBLY ARE
11 ENTITLED TO RECEIVE ONLY THE PER DIEM LODGING AND EXPENSE
12 ALLOWANCES AND THE TRAVEL EXPENSES AUTHORIZED BY SECTION
13 2-2-317; AND

14 (b) WHILE APPOINTED TO AND SERVING ON ANY STATE ENTITY
15 WHEN THE GENERAL ASSEMBLY IS IN RECESS FOR MORE THAN THREE DAYS
16 OR IS NOT IN SESSION, IN ADDITION TO THE BASE COMPENSATION SPECIFIED
17 IN SECTION 2-2-307 (1), CURRENT MEMBERS OF THE GENERAL ASSEMBLY
18 ARE ENTITLED TO RECEIVE THE AMOUNT SPECIFIED IN SECTION 2-2-307 (3)

19 (a) FOR NECESSARY ATTENDANCE AT MEETINGS OF THE STATE ENTITY AND

1 REIMBURSEMENT FOR ALL ACTUAL AND NECESSARY TRAVEL AND
2 SUBSISTENCE EXPENSES INCURRED IN CONNECTION WITH ATTENDANCE AT
3 MEETINGS OF THE STATE ENTITY. MILEAGE RATES SHALL NOT EXCEED
4 THOSE AUTHORIZED FOR THE EXECUTIVE DEPARTMENT. ALL
5 COMPENSATION PAID AND REIMBURSEMENTS MADE PURSUANT TO THIS
6 PARAGRAPH (b) SHALL BE PAID FROM APPROPRIATIONS MADE TO THE
7 LEGISLATIVE DEPARTMENT.

8 (2) FOR PURPOSES OF THIS SECTION, "STATE ENTITY" MEANS ANY
9 BOARD, COMMISSION, COMMITTEE, TASK FORCE, AUTHORITY, ENTERPRISE,
10 COUNCIL, WORKING GROUP, REVIEW TEAM, OR OTHER ENTITY CREATED OR
11 AUTHORIZED BY STATUTE ON WHICH CURRENT MEMBERS OF THE GENERAL
12 ASSEMBLY ARE STATUTORILY REQUIRED TO BE APPOINTED TO SERVE;
13 EXCEPT THAT "STATE ENTITY" DOES NOT INCLUDE THE COLORADO
14 COMMISSION ON UNIFORM STATE LAWS CREATED IN SECTION 2-3-601 (1)
15 OR THE EDUCATION COMMISSION OF THE STATES CREATED PURSUANT TO
16 SECTION 24-60-1201, C.R.S.

17 **SECTION 2.** In Colorado Revised Statutes, 1-1-115, **amend** (3)
18 (b) (III) as follows:

19 **1-1-115. Colorado voter access and modernized elections**
20 **commission - creation - composition - terms - duties - report -**
21 **definition - repeal.** (3) (b) (III) EXCEPT AS OTHERWISE PROVIDED IN
22 SECTION 2-2-326, C.R.S., members of the commission serve without
23 compensation, but are entitled to receive reimbursement for reasonable
24 expenses to be paid out of the department of state cash fund created in
25 section 24-21-104 (3) (b), C.R.S.

26 **SECTION 3.** In Colorado Revised Statutes, 2-3-1503, **amend** (3)
27 as follows:

1 **2-3-1503. Legislative emergency preparedness, response, and**
2 **recovery committee - creation - membership - duties.** (3) EXCEPT AS
3 OTHERWISE PROVIDED IN SECTION 2-2-326, the members of the legislative
4 committee shall serve without compensation. ~~but the senators and~~
5 ~~representatives serving on the legislative committee shall be entitled to~~
6 ~~reimbursement of expenses incurred in serving on the legislative~~
7 ~~committee.~~

8 **SECTION 4.** In Colorado Revised Statutes, 10-8-505, **amend** (8)
9 as follows:

10 **10-8-505. CoverColorado board of directors.** (8) Members of
11 the board shall serve without compensation EXCEPT AS OTHERWISE
12 PROVIDED IN SECTION 2-2-326, C.R.S., AND except that they shall be
13 reimbursed for any actual and necessary expenses incurred in the
14 performance of their duties under this part 5, with mileage rates not to
15 exceed those authorized for the executive department.

16 **SECTION 5.** In Colorado Revised Statutes, 11-59-105, **amend**
17 (1) (a) as follows:

18 **11-59-105. Colorado municipal bond supervision advisory**
19 **board - creation.** (1) (a) There is hereby created the Colorado municipal
20 bond supervision advisory board, to be composed of three members of the
21 general assembly, one municipal securities broker-dealer representative,
22 one representative of a county, one representative of a municipality, one
23 representative of a special district, one representative of banks that act as
24 indenture trustees for municipal bond offerings, one bond counsel
25 representative, one real estate developer representative, three members of
26 the general public with experience in municipal financing as investors
27 who are not associated with any of the other members or interests, and

1 four owners of residential real property located in special districts who
2 are not associated with any of the other members or interests. Except for
3 the legislative members, members of the board shall be appointed by the
4 governor, who shall take into account the extent to which the board
5 represents the geographic areas, population concentrations, and ethnic
6 communities of this state. Appointments by the governor shall be for a
7 period of four years. The three members of the general assembly shall be
8 appointed one each by the governor, the speaker of the house of
9 representatives, and the president of the senate. No more than two of said
10 legislative members may be from the same major political party, and,
11 except as provided in paragraph (b) of this subsection (1), each such
12 legislative member shall be appointed for a term of two years or for the
13 same term to which they were elected, whichever is less. Successors shall
14 be appointed in the same manner as the original members. Vacancies of
15 all other members shall be filled by appointment by the governor for
16 unexpired terms. In the case of a vacancy, the remaining members of the
17 board shall exercise all the powers and authority of the board until such
18 vacancy is filled. The board shall choose its own chairperson by majority
19 vote of the quorum present at a meeting called for the purpose of electing
20 a chairperson. The board shall meet not less than annually. EXCEPT AS
21 OTHERWISE PROVIDED IN SECTION 2-2-326, C.R.S., members of the board
22 shall receive no compensation but shall be reimbursed for all actual and
23 necessary expenses incurred in the performance of their duties, AND such
24 expenses shall be paid from the appropriations from the division of
25 securities cash fund created in section 11-51-707. A majority of the board
26 shall constitute a quorum to transact business and for the exercise of any
27 of the powers or authority conferred.

1 **SECTION 6.** In Colorado Revised Statutes, 12-47.1-1602, **add**
2 (4) as follows:

3 **12-47.1-1602. Local government limited gaming impact**
4 **advisory committee - creation - duties.** (4) THE MEMBERS OF THE
5 COMMITTEE APPOINTED PURSUANT TO PARAGRAPHS (f) AND (g) OF
6 SUBSECTION (1) OF THIS SECTION ARE ENTITLED TO RECEIVE
7 COMPENSATION AND REIMBURSEMENT OF EXPENSES AS PROVIDED IN
8 SECTION 2-2-326, C.R.S.

9 **SECTION 7.** In Colorado Revised Statutes, 14-10-115, **amend**
10 (16) (d) as follows:

11 **14-10-115. Child support guidelines - purpose - definitions -**
12 **determination of income - schedule of basic child support obligations**
13 **- adjustments to basic child support - additional guidelines - child**
14 **support commission.** (16) **Child support commission.** (d) Members
15 of the child support commission shall not be compensated for their
16 services on the commission except AS OTHERWISE PROVIDED IN SECTION
17 2-2-326, C.R.S., AND EXCEPT that members shall be reimbursed for actual
18 and necessary expenses for travel and mileage incurred in connection
19 with their duties. The child support commission is authorized, subject to
20 appropriation, to incur expenses related to its work, including the costs
21 associated with public hearings, printing, travel, and research.

18 unless reappointed by the governor and reconfirmed by the senate at the
19 conclusion of said four years. Vacancies in either of the appointed
20 positions on the state board of equalization shall be filled by appointment
21 by the governor with the consent of the senate for the unexpired term.

22 **SECTION 30. Appropriation - adjustments to 2014 long bill.**

23 (1) For the implementation of this act, the general fund appropriation
24 made in the annual general appropriation act to the controlled
25 maintenance trust fund created in section 24-75-302.5 (2) (a), Colorado
26 Revised Statutes, for the fiscal year beginning July 1, 2014, is decreased
27 by \$85,690.

1 (2) For the implementation of this act, appropriations made in the
2 annual general appropriation act to the department of public safety for the
3 fiscal year beginning July 1, 2014, are adjusted as follows:

4 (a) The general fund appropriation for the division of criminal
5 justice is decreased by \$1,408.

6 (3) For the implementation of this act, appropriations made in the
7 annual general appropriation act to the department of local affairs for the
8 fiscal year beginning July 1, 2014, are adjusted as follows:

9 (a) The cash funds appropriation from the local government
10 limited gaming impact fund created in section 12-47.1-1601 (1) (a),
11 Colorado Revised Statutes, for the division of local government, is
12 decreased by \$352.

13 (4) For the implementation of this act, appropriations made in the
14 annual general appropriation act to the department of state for the fiscal
15 year beginning July 1, 2014, are adjusted as follows:

16 (a) The cash funds appropriation from the department of state cash
17 fund created in section 24-21-104 (3) (b), Colorado Revised Statutes, for
18 the elections division, is decreased by \$2,816.

19 **SECTION 31. Appropriation.** In addition to any other
20 appropriation, there is hereby appropriated, out of any moneys in the
21 general fund not otherwise appropriated, to the legislative department, for
22 the fiscal year beginning July 1, 2014, the sum of \$87,098, or so much
23 thereof as may be necessary, to be allocated to the general assembly for
24 the implementation of this act.

25 **SECTION 32. Applicability.** This act applies for service
26 provided to a state entity on or after the effective date of this act.

27 **SECTION 33. Safety clause.** The general assembly hereby finds,

- 1 determines, and declares that this act is necessary for the immediate
- 2 preservation of the public peace, health, and safety.
