	A BILL FOR AN ACT
101	CONCERNING SKI AREA SAFETY, AND, IN CONNECTION THEREWITH,
102	REQUIRING THE OPERATORS OF SKI AREAS TO ADOPT AND
103	DISCLOSE SAFETY PLANS, DISCLOSE SEASONAL SKI ACCIDENT
104	STATISTICS, AND MAINTAIN AN ACCIDENT DATABASE.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://leg.colorado.gov.)

The bill updates the "Ski Safety Act of 1979" by:

 Requiring each ski area to adopt and publish, in printed form and on the ski area's website, if any, a safety plan specifying the governance, management, and operational roles, responsibilities, and practices of the ski area to prevent accidents and reduce the frequency and severity of injuries; and

- Requiring ski areas with an elevation drop of 500 feet or more and at least one elevated lift to:
 - Collect and disseminate seasonal data on ski and snowboard accidents and deaths, including those occurring while boarding or exiting lifts; and
 - Collect and make available, upon request, specific information about each accident, including where and when it occurred, the conditions at the time, the type of injuries and whether death occurred on site or following medical transport, and specified nonprivate information about the injured person.

The bill makes any failure to create, maintain, and publish a safety plan or provide the required reports or data grounds for discipline by the passenger tramway safety board.

12	competition, a special event, or training or practicing for competition or
13	a special event on any portion of the area made available by the ski area
14	operator.
15	(3) (5) "Conditions of ordinary visibility" means daylight and,
16	where applicable, nighttime in nonprecipitating weather.
17	(6) "Database" means a collection of data elements
18	ORGANIZED, MAINTAINED ELECTRONICALLY, AND CAPABLE OF BEING
19	SEARCHED TO ENABLE STATISTICAL ANALYSIS.
20	(3.1) (7) "Extreme terrain" means any place within the ski area
21	boundary that contains cliffs with a minimum twenty-foot rise over a
22	fifteen-foot run, and slopes with a minimum fifty-degree average pitch
23	over a one-hundred-foot run.
24	(3.3) (8) "Freestyle terrain" includes but is not limited to, terrain
25	parks and terrain park features such as jumps, rails, fun boxes, and all
26	other constructed and natural features, half-pipes, quarter-pipes, and
27	freestyle-bump terrain.

18	(8) (18) "Skier" means any person using a ski area for the purpose
19	of skiing. which includes, without limitation, sliding downhill or jumping
20	on snow or ice on skis, a toboggan, a sled, a tube, a snowbike, a
21	snowboard, or any other device; or for the purpose of using any of the
22	facilities of the ski area, including but not limited to ski slopes and trails.
23	(19) "SKIER DAY" MEANS EACH OCCASION ON WHICH A TRAMWAY
24	TICKET OR SEASON PASS IS USED BY AN INDIVIDUAL FOR ACCESS TO A SKI
25	AREA FOR ALL OR PART OF A DAY.
26	(20) "SKIING" MEANS SLIDING DOWNHILL OR JUMPING ON SNOW OR
27	ICE ON SKIS, A TOBOGGAN, A SLED, A TUBE, A SNOWBIKE, A SNOWBOARD,
