A BILL FOR AN ACT

101 **CONCERNING BALLOT ACCESS FOR VOTERS WITH DISABILITIES, AND, IN**
102 **CONNECTION THEREWITH, MAKING AN APPROPRIATION.**

Bill Summary

The bill requires the secretary of state is to establish procedures to enable voters with disabilities to independently mark a paper ballot using nonvisual access or low vision access technology whether the voter is voting in a mail ballot election or voting at a polling location.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add** 1-5-706 as
3 follows:

4 **1-5-706. Ballot access for voters with disabilities.** THE
5 SECRETARY OF STATE SHALL ESTABLISH PROCEDURES TO ENABLE VOTERS
6 WITH DISABILITIES TO INDEPENDENTLY MARK A BALLOT OR USE AN
7 ELECTRONIC VOTING DEVICE THAT PRODUCES A PAPER RECORD USING
8 NONVISUAL ACCESS OR LOW VISION ACCESS TECHNOLOGY WHETHER THE
9 VOTER IS VOTING IN A MAIL BALLOT ELECTION PURSUANT TO ARTICLE 7.5
10 OF THIS TITLE 1 OR VOTING AT A POLLING LOCATION. THE PROCEDURES
11 SHALL INCLUDE A METHOD, TO BE DETERMINED BY THE SECRETARY OF
12 STATE, BY WHICH A VOTER WITH A DISABILITY MAY REQUEST SUCH A
13 BALLOT.

14 **SECTION 2. Appropriation.** For the 2019-20 state fiscal year,
15 \$50,000 is appropriated to the department of state for use by the
16 information technology division. This appropriation is from the
17 department of state cash fund created in section 24-21-104 (3)(b), C.R.S.
18 To implement this act, the division may use this appropriation for
19 personal services.

20 **SECTION 3. Act subject to petition - effective date.** This act
21 takes effect at 12:01 a.m. on the day following the expiration of the
22 ninety-day period after final adjournment of the general assembly (August
23 2, 2019, if adjournment sine die is on May 3, 2019); except that, if a
24 referendum petition is filed pursuant to section 1 (3) of article V of the
25 state constitution against this act or an item, section, or part of this act
26 within such period, then the act, item, section, or part will not take effect
27 unless approved by the people at the general election to be held in

- 1 November 2020 and, in such case, will take effect on the date of the
- 2 official declaration of the vote thereon by the governor.
