A BILL FOR AN ACT

101	CONCERNING CREATING A LEGISLATIVE COMMITTEE ON SAFETY IN
102	SCHOOLS, AND, IN CONNECTION THEREWITH, MAKING AN
103	APPROPRIATION.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill creates the school safety and youth mental health committee (committee) to:

! Study issues relating to school safety and the prevention of threats to the safety of students, teachers, administrators, employees, and volunteers;

- ! Study and evaluate programs and methods for identifying and monitoring students in crisis;
- ! Develop standardized criteria for school personnel to use in assessing the potential threat posed by one or more students; and
- ! Make recommendations to the education committees of the general assembly.

The committee shall meet at least 4 times each legislative interim and may meet as necessary throughout the year. Each appointing party shall make his or her appointment or appointments to the committee on or before June 1, 2015.

4	SECTION 2. Appropriation. (1) For the 2015-16 state fiscal
5	year, \$25,857 is appropriated to the legislative department. This
6	appropriation is from the general fund. To implement this act, the
7	department may use this appropriation as follows:
8	(a) \$16,881 for use by the legislative council, which amount is
9	based on an assumption that the legislative council will require an
10	additional 0.3 FTE; and
11	(b) \$8,976 for use by the general assembly.
12	SECTION <u>3.</u> Safety clause. The general assembly hereby finds,
13	determines, and declares that this act is necessary for the immediate
14	preservation of the public peace, health, and safety.
