102	CONNECTION THEREWITH, SUSPENDING LEGISLATIVE INTERIM
103	ACTIVITIES DURING THE 2020 INTERIM AND CHANGING THE
104	MINIMUM NUMBER OF MEETINGS THAT THE EARLY CHILDHOOD
105	AND SCHOOL READINESS LEGISLATIVE COMMISSION MUST HOLD
106	TO BE THE MAXIMUM NUMBER OF MEETINGS ANNUALLY THAT
107	THE COMMISSION MAY HOLD.

## **Bill Summary**

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at <a href="http://leg.colorado.gov/">http://leg.colorado.gov/</a>.)

**Executive Committee of the Legislative Council.** The bill suspends legislative interim committee activities during the 2020 interim. Specifically, the bill:

Prohibits the legislative council of the general assembly from prioritizing any requests for legislative interim committees, including task forces, for the 2020 interim; and ļ **Prohibits** meetings. field trips, and recommendations and reports by, and suspends for one year certain reports required to be submitted to, existing legislative interim committees, including the Colorado youth advisory council review committee; wildfire matters review committee; statewide health care review committee; Colorado health insurance exchange oversight committee; pension review commission and pension review subcommittee; early childhood and school readiness legislative commission; water resources review committee; and transportation legislation review committee.

Additionally, the bill removes the requirement that the early childhood and school readiness legislative commission meet at least 4 times each year and instead limits the commission to up to 4 meetings per year.

Be it enacted by the General Assembly of the State of Colorado:

The director of research of the legislative council and the director of the office of legislative legal services shall provide staff assistance to the interim committee COMMISSION. The commission shall study issues concerning early childhood and school readiness, including but not limited to health care, mental health, parental involvement, family support, child care, and early learning. The commission shall solicit input from members of the public, especially those individuals with expertise related to early childhood and school readiness issues, to aid the commission in its work. The commission shall consult with the early childhood leadership commission, created in section 26-6.2-103, with regard to policies concerning early childhood and school readiness.
