The bill extends the Colorado economic development commission by changing the repeal date of its organic statute to July 1, 2025.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-46-105, **amend**

3 **(1)** as follows:

4 **24-46-105. Colorado economic development fund - creation.**

5 **(1)** There is hereby created a fund to be known as the Colorado economic  
6 **development fund, referred to in this part 1 as the "fund", which shall be**  
7 **administered by the commission and which shall consist of all moneys**  
8 **that may be available to it THE COMMISSION. THE COMMISSION MAY**  
9 **TRANSFER TO THE FUND ANY GENERAL FUND MONEY APPROPRIATED TO**  
10 **THE COMMISSION AND THE COMMISSION MAY EXPEND SUCH MONEY**  
11 **WITHOUT FURTHER APPROPRIATION.**

12 **SECTION 2.** In Colorado Revised Statutes, **amend** 24-46-106 as  
13 follows:

14 **24-46-106. Repeal of part.** This part 1 is repealed, effective July  
15 ~~1,~~ 2017 JULY 1, 2025.

16 **SECTION 3. Appropriation.** For the 2017-18 state fiscal year,  
17 **\$5,000,000 is appropriated to the office of the governor for use by the**  
18 **Colorado office of economic development. This appropriation is from the**  
19 **general fund and is based on an assumption that the office will require an**  
20 **additional 4.0 FTE. To implement this act, the office may use this**  
21 **appropriation for the economic development commission - general**  
22 **economic incentives and marketing.**

23 **SECTION 4. Safety clause.** The general assembly hereby finds,  
24 determines, and declares that this act is necessary for the immediate  
25 preservation of the public peace, health, and safety.
