WHEREAS, Dorothy ("Dottie") Stonecipher Wham departed this life on October 20, 2019; and
WHEREAS, Dottie was born in Centralia, Illinois on January 5, 1925; and
WHEREAS, Dottie received a bachelor's degree from McMurray College, a master's degree from the University of Illinois, and an honorary doctorate from McMurray College as a distinguished alumna; and
WHEREAS, Dottie married her high school sweetheart, Robert Wham, on January 26, 1947; and

3 4 5	WHEREAS, Dottie served as the Regional Director for Colorado and Wyoming for the federal domestic volunteer agency known as "ACTION" for 10 years; and
6 7 8	WHEREAS, Dottie served in the Colorado House of Representatives from 1983 to 1986, and in the Colorado Senate from 1986 to 2000; and
9 10	WHEREAS, Dottie served as Chair of the Senate Judiciary Committee for 12 years; and
11 12	WHEREAS, Dottie was the first person to chair the Senate Judiciary Committee who was not an attorney; and
13 14 15	WHEREAS, During her legislative career, Dottie served as the prime sponsor for 321 House and Senate bills, of which 243 were enacted into law; and
16 17 18 19	WHEREAS, One of the accomplishments of which Senator Wham was very proud was her work to establish a trauma system throughout the state to ensure that persons injured by trauma were taken to the most appropriate facility as quickly as possible; and
20 21 22 23	WHEREAS, The establishment of the trauma system took 9 years of work with other legislators, rural and urban hospitals, patient representatives, fire departments, and professional associations of physicians, nurses, and emergency medical technicians; and
24 25	WHEREAS, That system is still in place and operating smoothly today; and
26 27 28 29 30	WHEREAS, Other bills of note carried by Dottie Wham include bills to establish confidential testing for the HIV virus, establishment of a system to test all newborn infants in the state for hearing loss, standards and procedures for advanced directives for end of life care, and several omnibus criminal justice bills; and
31	WHEREAS, Dottie Wham was recognized by the Hon. Scott
