## "AN ACT CONCERNING RESPONSIBLE AND EQUITABLE REGULATION OF ADULT-USE CANNABIS."

- Strike subdivision (8) of section 5 in its entirety and substitute the following in lieu thereof:
- 3 "(8) "Serious juvenile offense" means (A) the violation of, including
- 4 attempt or conspiracy to violate, section 21a-277, 21a-278, 29-33, 29-34,
- 5 29-35, subdivision (2) or (3) of subsection (a) of section 53-21, 53-80a, 53-
- 6 202b, 53-202c, 53-390 to 53-392, inclusive, 53a-54a to 53a-57, inclusive,
- 7 53a-59 to 53a-60c, inclusive, 53a-64aa, 53a-64bb, 53a-70 to 53a-71,
- 8 inclusive, 53a-72b, 53a-86, 53a-92 to 53a-94a, inclusive, 53a-95, 53a-
- 9 100aa, 53a-101, 53a-102a, 53a-103a or 53a-111 to 53a-113, inclusive,
- subdivision (1) of subsection (a) of section 53a-122, subdivision (3) of
- 11 subsection (a) of section 53a-123, section 53a-134, 53a-135, 53a-136a or
- 12 53a-167c, subsection (a) of section 53a-174, or section 53a-196a, 53a-211,
- 13 53a-212, 53a-216 or 53a-217b, [or] (B) absconding, escaping or running
- 14 away, without just cause, from any secure residential facility in which

- 16 second or subsequent violation of subdivision (3) of subsection (a) of
- 17 <u>section 53a-122</u>, <u>subdivision (1) of subsection (a) of section 53a-123</u>, <u>or</u>
- 18 <u>subdivision (1) of subsection (a) of section 53a-124;</u>"
- After the last section, add the following and renumber sections and
- 20 internal references accordingly:
- 21 "Sec. 501. Subsection (k) of section 46b-133 of the general statutes is
- 22 repealed and the following is substituted in lieu thereof (Effective October
- 23 1, 2021):
- 24 (k) For purposes of subsections (c) and (e) of this section, a child may
- 25 be determined to pose a risk to public safety if such child (1) has
- 26 previously been adjudicated as delinquent for or convicted of or pled
- 27 guilty or nolo contendere to two or more felony offenses, (2) has had
- 28 two or more prior dispositions of probation and is charged with
- 29 commission of a larceny under subdivision (3) of subsection (a) of
- 30 section 53a-122 or subdivision (1) of subsection (a) of section 53a-123 or
- 31 subdivision (1) of subsection (a) of section 53a-124, or (3) is charged with
- 32 <u>the commission of a serious juvenile offense."</u>
