## AN ACT CONCERNING SAME-DAY CAR DEALER REGISTRATIONS.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 Section 1. Subsection (c) of section 14-12 of the general statutes is
- 2 repealed and the following is substituted in lieu thereof (*Effective October*
- 3 1, 2023):
- 4 (c) (1) The commissioner may, for the more efficient administration
- 5 of the commissioner's duties, appoint licensed dealers meeting
- 6 qualifications established by the commissioner pursuant to regulations
- 7 adopted in accordance with the provisions of chapter 54, to (A) issue
- 8 new registrations for passenger motor vehicles, motorcycles, campers,
- 9 camp trailers, commercial trailers, service buses, school buses, trucks or
- 10 other vehicle types as determined by the commissioner, and (B) renew
- 11 such registrations for such vehicle types. A person registering or
- 12 renewing the registration of a motor vehicle or other vehicle type as
- determined by the commissioner [from] through a dealer so appointed
- 14 shall file an application with the dealer and pay, to the dealer, the
- 15 registration fee in accordance with the provisions of section 14-49 and
- any other applicable fees. The commissioner may authorize such dealer
- 17 to retain a service fee paid by the person registering or renewing the

- 18 registration of a motor vehicle under this subsection. The commissioner
- 19 shall establish the maximum service fee that such dealer may charge and
- 20 prescribe the time and manner in which the application and fees, other
- 21 than the service fee, shall be transmitted to the commissioner, except the
- 22 commissioner shall permit dealers requesting to register motor vehicles
- 23 on the same day of such request to do so at any branch office of the
- 24 Department of Motor Vehicles without requiring such dealers to make
- 25 an appointment with such branch office.
- 26 (2) The commissioner shall permit a licensed dealer appointed 27 pursuant to subdivision (1) of this subsection to electronically register a 28 motor vehicle that has a gross vehicle weight rating in excess of twenty-
- 29 six thousand pounds and is used or operated in intrastate commerce.
- 30 Such dealer shall pay all applicable registration and title fees for each
- 31 such registration.

This act shall take effect as follows and shall amend the following sections:
