AN ACT PROHIBITING THE COMMISSIONER OF ADMINISTRATIVE SERVICES FROM DELEGATING THE RESPONSIBILITY OF ADMINISTERING THE SCHOOL BUILDING PROJECTS GRANT PROGRAM TO THE SECRETARY OF THE OFFICE OF POLICY AND MANAGEMENT AND REQUIRING THE DEPARTMENT OF ADMINISTRATIVE SERVICES TO MAINTAIN A DATABASE OF INFORMATION RELATING TO SCHOOL BUILDING PROJECTS ON THE DEPARTMENT'S INTERNET WEB SITE.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

Section 1. (NEW) (*Effective from passage*) Notwithstanding the provisions of section 4-8 of the general statutes, the Commissioner of

4 memorandum of understanding or any other contractual agreement

state agency, as defined in section 4-37e of the general statutes, to

9 responsibilities of administering or implementing the school building

10 project grant program under chapter 173 of the general statutes to such

11 state agency. Any such memorandum of understanding or contractual

agreement entered into by the commissioner before the effective date of this section shall be void.

14 Sec. 2. (NEW) (Effective from passage) The Department of 15 Administrative Services shall maintain a publicly accessible database of information relating to school building projects for which a school 16 17 building project grant has been authorized under chapter 173 of the 18 general statutes. Such database shall include at least the following: (1) 19 Each listing of eligible school building projects listed by category 20 together with the amount of the estimated grants for such projects, 21 prepared by the Commissioner of Administrative Services pursuant to 22 section 10-283 of the general statutes, commencing with the list 23 submitted prior to December 15, 1999, to a committee of the General 24 Assembly established pursuant to section 10-283a of the general 25 statutes, and (2) information relating to each school building project for 26 which a school building project grant has been authorized on or after 27 January 1, 2000, including, but not limited to, (A) the project start date, 28 (B) the actual or anticipated completion date, (C) payments made for 29 such project, (D) the estimated and actual costs, including any revisions, 30 of such project, and (E) the project type. The department shall annually 31 update such database on or before January first of each year and make 32 such database available on its Internet web site.

Statement of Purpose:

To prohibit the Commissioner of Administrative Services from entering into a memorandum of understanding with the Secretary of the Office of Policy and Management to delegate the responsibility of administering the school building projects grant program, and to require the Department of Administrative Services to maintain and update a database of information relating to school building projects on the department's Internet web site.
