AN ACT CONVEYING A PARCEL OF STATE LAND IN THE TOWN OF WOODSTOCK.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 Section 1. (Effective from passage) (a) Notwithstanding any provision
- 2 of the general statutes, the Commissioner of Energy and Environmental
- 3 Protection shall convey to the Young Men's Christian Association
- 4 (YMCA) of Metropolitan Hartford, Inc., for the benefit of Young Men's
- 5 Christian Association (YMCA) Camp Woodstock, a parcel of land
- 6 located in the town of Woodstock, at a cost equal to the administrative
- 7 costs of making such conveyance. Said parcel of land has an area of
- 8 approximately 19.3 acres and is identified as Lot 35-09 on the town of
- 9 Woodstock Tax Assessor's Map 7272, and borders Camp Road. The
- 10 conveyance shall be subject to the approval of the State Properties
- 11 Review Board.
- 12 (b) The Young Men's Christian Association (YMCA) of Metropolitan
- 13 Hartford, Inc., shall use said parcel of land for seasonal recreation and
- other purposes related to Camp Woodstock. If the association:

- 15 (1) Does not use said parcel for said purposes;
- 16 (2) Does not retain ownership of all of said parcel; or
- 17 (3) Leases all or any portion of said parcel,
- the parcel shall revert to the state of Connecticut.
- 19 (c) The State Properties Review Board shall complete its review of the 20 conveyance of said parcel of land not later than thirty days after it 21 receives a proposed agreement from the Department of Energy and 22 Environmental Protection. The land shall remain under the care and 23 control of said department until a conveyance is made in accordance 24 with the provisions of this section. The State Treasurer shall execute and 25 deliver any deed or instrument necessary for a conveyance under this 26 section, which deed or instrument shall include provisions to carry out 27 the purposes of subsection (b) of this section. The Commissioner of 28 Energy and Environmental Protection shall have the sole responsibility 29 for all other incidents of such conveyance.

This act shall take effect as follows and shall amend the following

To convey a parcel of state land in the town of Woodstock to the YMCA of Metropolitan Hartford, Inc. for seasonal recreation and other purposes related to Camp Woodstock.
