## AN ACT EXTENDING THE PERIOD A CHILD, STEPCHILD OR OTHER DEPENDENT CHILD MAY RETAIN DENTAL INSURANCE COVERAGE UNDER A PARENT'S HEALTH INSURANCE POLICY.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

Section 1. Section 38a-497 of the general statutes is repealed and the
following is substituted in lieu thereof (*Effective January 1, 2020*):

3 (a) Each individual health insurance policy providing coverage of 4 the type specified in subdivisions (1), (2), (4), (6), (10), (11) and (12) of section 38a-469 delivered, issued for delivery, amended, renewed or 5 6 continued in this state shall provide that coverage of a child, stepchild 7 or other dependent child shall terminate [no] not earlier than the 8 policy anniversary date on or after whichever of the following occurs 9 first, the date on which the child, [:] <u>stepchild or other dependent child</u>: 10 (1) Becomes covered under a group health plan through the [dependent's] child's, stepchild's or other dependent child's own 11 12 employment; or (2) attains the age of twenty-six.

13 (b) Each individual health insurance policy described in subsection 14 (a) of this section, and each individual health insurance policy

15 providing coverage of the type specified in subdivision (16) of section 16 38a-469 delivered, issued for delivery, amended, renewed or continued 17 in this state, that includes or provides dental coverage shall provide 18 that dental coverage of a child, stepchild or other dependent child shall 19 terminate not earlier than the policy anniversary date on or after 20 whichever of the following occurs first, the date on which the child, 21 stepchild or other dependent child: (1) Becomes covered under a group 22 health plan through the child's, stepchild's or other dependent child's 23 own employment; or (2) attains the age of twenty-six. 24 (c) Each [such] policy subject to this section shall cover a stepchild 25 or other dependent child on the same basis as a biological child. 26 Sec. 2. Section 38a-512b of the general statutes is repealed and the 27 following is substituted in lieu thereof (*Effective January 1, 2020*): 28 (a) Each group health insurance policy providing coverage of the type specified in subdivisions (1), (2), (4), (6), (10), (11) and (12) of 29 section 38a-469 delivered, issued for delivery, amended, renewed or 30 31 continued in this state shall provide that coverage of a child, stepchild 32 or other dependent child shall terminate [no] not earlier than the

33 policy anniversary date on or after whichever of the following occurs 34 first, the date on which the child<sub>z</sub> [:] <u>stepchild or other dependent child</u>: 35 (<u>1</u>) Becomes covered under a group health plan through the 36 [dependent's] <u>child's, stepchild's or other dependent child's</u> own 37 employment; or (<u>2</u>) attains the age of twenty-six.

38 (b) Each group health insurance policy described in subsection (a) of 39 this section, and each group health insurance policy providing coverage of the type specified in subdivision (16) of section 38a-469 40 41 delivered, issued for delivery, amended, renewed or continued in this state, that includes or provides dental coverage shall provide that 42 43 dental coverage of a child, stepchild or other dependent child shall 44 terminate not earlier than the policy anniversary date on or after 45 whichever of the following occurs first, the date on which the child, 46 stepchild or other dependent child: (1) Becomes covered under a group

- 47 <u>health plan through the child's, stepchild's or other dependent child's</u>
- 48 <u>own employment; or (2) attains the age of twenty-six.</u>
- 49 (c) Each [such] policy <u>subject to this section</u> shall cover a stepchild
- 50 <u>or other dependent child</u> on the same basis as a biological child.

To allow children, stepchildren and other dependent children to retain dental insurance coverage under their parents' insurance policies until they attain the age of twenty-six or obtain substitute coverage through an employer.
