## AN ACT CONVEYING PARCELS OF STATE LAND TO THE CITY OF NEW HAVEN.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 Section 1. (Effective from passage) (a) Notwithstanding any provision
- of the general statutes, the chairperson of the Board of Regents for
- 3 Higher Education shall convey to the city of New Haven two parcels of
- 4 land located in the city of New Haven, at a cost equal to the
- 5 administrative costs of making such conveyance. Said parcels of land
- 6 have a combined area of approximately 7.23 acres and are identified as
- 7 60 Sargent Drive at Lot 200 in Block 1304 on city of New Haven Tax
- 8 Assessor's Map 234 and 0 Sargent Drive at Lot 403 in Block 1304 on city
- 9 of New Haven Tax Assessor's Map 235. The conveyance shall be subject
- 10 to the approval of the State Properties Review Board.
- 11 (b) The city of New Haven shall use said parcels of land for economic
- development or municipal purposes and may sell or lease a portion or
- all of said parcel for economic development purposes. If the city of New

- 15 (1) Does not use said parcels for either of said purposes;
- 16 (2) Does not retain ownership of all of said parcels, other than a sale 17 for economic development purposes; or
- 18 (3) Leases all or any portion of said parcels, other than a lease for economic development purposes,
- the parcels shall revert to the state of Connecticut. Any sale of said parcel pursuant to this section shall be made at a cost equal to the fair market value of said parcel, as determined by the average of the appraisals of two independent appraisers selected by the chairperson. Any funds received by the city of New Haven from a sale or lease in accordance with this subsection shall be transferred to the State Treasurer for deposit in the General Fund.
- 27 (c) The State Properties Review Board shall complete its review of the 28 conveyance of said parcels of land not later than thirty days after it 29 receives a proposed agreement from the Board of Regents for Higher 30 Education. The land shall remain under the care and control of the 31 Board of Regents for Higher Education until a conveyance is made in 32 accordance with the provisions of this section. The State Treasurer shall 33 execute and deliver any deed or instrument necessary for a conveyance 34 under this section, which deed or instrument shall include provisions to 35 carry out the purposes of subsection (b) of this section. The chairperson 36 of the Board of Regents for Higher Education shall have the sole 37 responsibility for all other incidents of such conveyance.
