AN ACT ESTABLISHING A PILOT PROGRAM FOR CURBSIDE FOOD WASTE COLLECTION USED IN ANAEROBIC DIGESTERS.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 (NEW) (Effective October 1, 2019) Notwithstanding the provisions of 2 chapter 446d of the general statutes, the Department of Energy and 3 Environmental Protection shall establish a municipal curbside food 4 waste collection pilot program. Such pilot program shall consist of 5 three municipalities that are located not more than twenty miles from a 6 permitted and operational anaerobic digester in the state. The 7 Commissioner of Energy and Environmental Protection shall provide 8 for the coordination among such municipalities, the department, 9 collectors of solid waste and the owner or operator of such anaerobic 10 digesters to establish the separate curbside collection of food waste 11 from subscribed or designated residential customers of such collectors 12 for a six-month period and for the use of such separately collected food 13 waste in such anaerobic digester. Each collector shall provide each 14 residential customer of such collector who participates in such pilot 15 program with educational materials that instruct such residential 16 customer on how to properly participate in such program and

17 segregate food waste for collection. Additionally, each residential 18 customer who participates in such pilot program shall be provided a 19 countertop compost bin and certified compostable bags by such 20 collector at no charge or a reduced charge. The Commissioner of 21 Energy and Environmental Protection shall submit a report, in 22 accordance with the provisions of section 11-4a of the general statutes, 23 to the joint standing committee of the General Assembly having 24 cognizance of matters relating to the environment on the status of such 25 pilot program and any recommendations for continuation or 26 expansion of such pilot program. Such report shall be submitted to 27 said committee not later than February 1, 2020. For purposes of this 28 section, "certified compostable bag" means any bag made from 29 materials that are compostable to ASTM D6400 standard and third-30 party BPI Certified, certified as home compostable by TUV 31 Compostable Home Certification and that contain a minimum of forty 32 per cent plant-sourced renewable content and that are green or brown 33 in color.

This act shall take effect as follows and shall amend the following sections:
