***AN ACT ESTABLISHING THE CONNECTICUT-IRELAND TRADE COMMISSION.***

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. (NEW) (*Effective from passage*) (a) There is established a  
2 Connecticut-Ireland Trade Commission, which shall be part of the  
3 Legislative Department.

4 (b) The commission shall consist of the following members:

5 (1) Two appointed by the speaker of the House of Representatives,  
6 who have current or past involvement in organizations that promote  
7 Irish affairs or are interested in the well-being of trade relations between  
8 the state and Ireland;

9 (2) Two appointed by the president pro tempore of the Senate, who  
10 have current or past involvement in organizations that promote Irish  
11 affairs or are interested in the well-being of trade relations between the  
12 state and Ireland;

13 (3) Two appointed by the majority leader of the House of

14 Representatives, who have current or past involvement in organizations  
15 that promote Irish affairs or are interested in the well-being of trade  
16 relations between the state and Ireland;

17 (4) Two appointed by the majority leader of the Senate, who have  
18 current or past involvement in organizations that promote Irish affairs  
19 or are interested in the well-being of trade relations between the state  
20 and Ireland;

21 (5) Two appointed by the minority leader of the House of  
22 Representatives, who have current or past involvement in organizations  
23 that promote Irish affairs or are interested in the well-being of trade  
24 relations between the state and Ireland;

25 (6) Two appointed by the minority leader of the Senate, who have  
26 current or past involvement in organizations that promote Irish affairs  
27 or are interested in the well-being of trade relations between the state  
28 and Ireland;

29 (7) Seven persons appointed by the Governor, who have current or  
30 past involvement in organizations that promote Irish affairs or are  
31 interested in the well-being of trade relations between the state and  
32 Ireland;

33 (8) A representative of a public institution of higher education in the  
34 state, who shall be appointed by the Governor;

35 (9) A representative of a chamber of commerce in the state, who shall  
36 be appointed by the Governor; and

37 (10) Two representatives of Irish-American communities in the state,  
38 who shall be appointed by the Governor and shall not be members of  
39 the same political party.

40 (c) Any member of the commission appointed under subdivisions (1)  
41 to (6), inclusive, of subsection (b) of this section may be a member of the  
42 General Assembly.

43 (d) All initial appointments to the commission shall be made not later  
44 than October 1, 2024. Initial appointments made by the Governor, the  
45 majority leader of the House of Representatives and the minority leader  
46 of the House of Representatives shall terminate on September 30, 2027.  
47 Initial appointments made by the speaker of the House of  
48 Representatives, the president pro tempore of the Senate, the majority  
49 leader of the Senate and the minority leader of the Senate shall terminate  
50 on September 30, 2028.

51 (e) The speaker of the House of Representatives and the president pro  
52 tempore of the Senate shall select the chairpersons of the commission  
53 from among the members of the commission. Such chairpersons shall  
54 schedule the first meeting of the commission, which shall be held not  
55 later than November 1, 2024.

56 (f) The administrative staff of the joint standing committee of the  
57 General Assembly having cognizance of matters relating to commerce  
58 shall serve as administrative staff of the commission.

59 (g) Appointed members of the commission shall serve for four-year  
60 terms which shall commence on the date of appointment, except as  
61 provided in subsection (d) of this section. Members shall continue to  
62 serve until their successors are appointed.

63 (h) Any vacancy shall be filled by the appointing authority. Any  
64 vacancy occurring other than by expiration of term shall be filled for the  
65 balance of the unexpired term.

66 (i) A majority of the commission shall constitute a quorum for the  
67 transaction of any business.

68 (j) The members of the commission shall serve without  
69 compensation, but shall, within the limits of available funds, be  
70 reimbursed for expenses necessarily incurred in the performance of  
71 their duties.

72 (k) The commission shall have the following powers and duties to:

73 (1) Advance bilateral trade and investment between the state and  
74 Ireland; (2) initiate joint action on policy issues of mutual interest to the  
75 state and Ireland; (3) promote business and academic exchanges  
76 between the state and Ireland; (4) encourage mutual economic support  
77 between the state and Ireland; (5) encourage mutual investment in the  
78 infrastructure of the state and Ireland; (6) address such other issues as  
79 determined by the commission; (7) obtain from any executive  
80 department, board, commission or other agency of the state such  
81 assistance and data as necessary and available to carry out the purposes  
82 of this section; (8) accept any gift, donation or bequest for the purpose  
83 of performing the duties described in this section; and (9) perform such  
84 other acts as may be necessary and appropriate to carry out the duties  
85 described in this section.

86 (l) The commission shall meet as often as deemed necessary by the  
87 chairpersons or a majority of the commission. Any appointed member  
88 who fails to attend three consecutive meetings or who fails to attend  
89 fifty per cent of all meetings held during any calendar year shall be  
90 deemed to have resigned from the commission.

91 (m) Not later than February 1, 2026, and annually thereafter, the  
92 commission shall submit a report, in accordance with the provisions of  
93 section 11-4a of the general statutes, to the Governor, the Commissioner  
94 of Economic and Community Development and the joint standing  
95 committee of the General Assembly having cognizance of matters  
96 relating to commerce on the activities of the commission during the  
97 preceding year, which shall include, but need not be limited to,  
98 recommendations for policy changes and amendments to the general  
99 statutes necessary to effectuate the purposes of the commission.

This act shall take effect as follows and shall amend the following sections:
