## AN ACT CONCERNING A CONVEYANCE OF A PARCEL OF STATE LAND IN THE CITY OF BRIDGEPORT.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 Section 1. (Effective from passage) (a) Notwithstanding any provision
- of the general statutes, the Commissioner of Administrative Services, on
- 3 behalf of the Commissioner of Motor Vehicles, shall convey to Island
- 4 Brook Joint Venture, LLC, a parcel of land located in the city of
- 5 Bridgeport, at a cost equal to one hundred fifty-five thousand dollars, in
- 6 accordance with the provisions of a lease agreement between the state
- 7 of Connecticut, signed thereby on October 11, 2001, and Island Brook
- 8 Joint Venture, LLC, signed thereby on October 15, 2001. Said parcel of
- 9 land has an area of approximately 1.5278 acres and is identified as
- 10 Parcels B, C, D and E on a map entitled "PROPERTY/BOUNDARY
- 11 SURVEY FOR ISLAND BROOK JOINT VENTURE, LLC PROPERTY
- 12 LOCATED ON SYLVAN AVE., GLENWOOD RD., COLONIAL AVE.
- 13 & CHOPSY HILL AVE. (State Route #722) BRIDGEPORT,

- 20 Bridgeport Land Records. Said parcel shall be conveyed subject to
- 21 easements for sanitary sewer, storm sewer and utilities in favor of the
- 22 city of Bridgeport. The conveyance shall be subject to the approval of
- 23 the State Properties Review Board.
- 24 (b) The State Properties Review Board shall complete its review of the 25 conveyance of said parcel of land not later than thirty days after it 26 receives a proposed agreement from the Department of Administrative 27 Services, on behalf of the Department of Motor Vehicles. The land shall 28 remain under the care and control of the Department of Motor Vehicles 29 until a conveyance is made in accordance with the provisions of this 30 section. The State Treasurer shall execute and deliver any deed or 31 instrument necessary for a conveyance under this section. The 32 Commissioner of Motor Vehicles shall have the sole responsibility for 33 all other incidents of such conveyance.

This act shall take effect as follows and shall amend the following sections:
