## AN ACT ALLOWING THE CONNECTICUT HEALTH AND EDUCATIONAL FACILITIES AUTHORITY TO MAKE LOANS FOR THE COST OF RELATED HEALTH CARE INSTITUTIONS.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

Section 1. Subsection (b) of section 10a-178 of the general statutes is
repealed and the following is substituted in lieu thereof (*Effective July* 1, 2019):

4 (b) "Project", (1) in the case of a participating institution for higher 5 education, means a structure suitable for use as a dormitory or other 6 housing facility, including housing for staff members, employees or 7 students at such institution of higher education, dining hall, student 8 union, administration building, academic building, library, laboratory, 9 research facility, classroom, athletic facility, health care facility, and 10 maintenance, storage or utility facility and other structures or facilities 11 related thereto or required or useful for the instruction of students or 12 the conducting of research or the operation of an institution for higher 13 education, including parking and other facilities or structures essential 14 or convenient for the orderly conduct of such institution for higher 15 education, also including equipment and machinery and other similar 16 items necessary or convenient for the operation of a particular facility 17 or structure in the manner for which its use is intended or for the 18 operation of a participating institution for higher education, or any

19 combination thereof, but shall not include such items as books, fuel, 20 supplies or other items the purchase of which is customarily deemed 21 to result in a current operating charge; (2) in the case of a participating 22 health care institution, means a structure suitable for use as a hospital, 23 clinic, or other health care facility, laboratory, laundry, residence 24 facility, including housing for nurses, interns, staff members, 25 employees or students at such health care institution and their 26 immediate families and for physically or mentally handicapped 27 persons, administration building, research facility, related health care 28 institution, as defined in subsection (r) of this section, and maintenance, storage or utility facility and other structures or facilities 29 30 related thereto or required or useful for the operation of the project, 31 including parking and other facilities or structures essential or 32 convenient for the orderly operation of such project, also including 33 equipment and machinery and other similar items necessary or 34 convenient for the operation of the project in the manner for which its 35 use is intended or for the operation of a participating health care 36 institution, or any combination thereof, but shall not include such 37 items as fuel, supplies or other items the purchase of which is 38 customarily deemed to result in a current operating charge; (3) in the 39 case of a participating qualified nonprofit organization, means a 40 structure or facility owned in its entirety by, or suitable for use in 41 accordance with the charitable or nonprofit status of the qualified 42 nonprofit organization, also including equipment and machinery and 43 other similar items necessary or convenient for the operation of the 44 project in the manner for which its use is intended or for the operation 45 of a participating qualified nonprofit corporation; and [,] (4) in the case 46 of a participating nursing home, means a structure or facility suitable 47 for use as a nursing home, residential care home, rest home, health 48 care facility for the handicapped, mental health facility or independent 49 living facility subject to the licensing requirements of chapter 368v and 50 appurtenant facilities, equipment and machinery and other similar 51 items necessary or convenient for the operation of a particular facility 52 or structure in the manner for which its use is intended or for the 53 operation of a participating nursing home;

54 Sec. 2. Section 10a-178 of the general statutes is amended by adding 55 subsection (r) as follows (*Effective July 1, 2019*):

56 (NEW) (r) "Related health care institution" means any hospital, 57 health care institution, institution, as defined in subsection (a) of 58 section 19a-490, that is constructed or acquired by a nonprofit, 59 nonstock corporation or any nonprofit, nonstock, nonsectarian health 60 care center that conducts activities and carries out purposes as 61 described in subsection (b) of section 38a-176, and (1) is located outside 62 of the state, (2) is a wholly owned or controlled subsidiary of a health care institution, as defined in subdivisions (1) and (2) of subsection (g) 63 64 of this section, licensed in the state, and (3) would be eligible to be 65 licensed as an institution under the provisions of sections 19a-490 to 66 19a-503, inclusive, if it was located in the state.
