16	Sec. 2. Section 2(a) of the Advisory Neighborhood Commission Boundaries Act of 2022,
17	effective August 10, 2022 (D.C. Law 24-148; D.C. Official Code § 1-309.03, note) is amended
18	as follows:
19	(a) The boundaries of SMD 6D01 are amended by striking the phrase "then due west
20	along a line extending from said intersection to the center line of the Washington Channel" and
21	inserting the phrase "then southeast along the shoreline of the Washington Channel to its
22	intersection with the southern boundary of Southwest Waterfront Park; then due west along a
23	line extending from such intersection to the center line of the Washington Channel" in its place.
24	(b) The boundaries of SMD 6D07 are amended by striking the phrase "a line extending
25	due west from a line following the eastern boundary of the drive lanes of the street identified as

26	Marina Way in Zoning Commission Order No. 11-03J(2), dated December 7, 2018, and
27	extending such eastern boundary to its intersection with the shoreline of the Washington
28	Channel; then due east along such line to the shoreline of the Washington Channel; then
29	southeast along the shoreline of the Washington Channel to the southern boundary of Southwest
30	Waterfront Park" and inserting the phrase "a line extending due west from the southern boundary
31	of Southwest Waterfront Park at its intersection with the shoreline of the Washington Channel;
32	then east along such line to the southern boundary of Southwest Waterfront Park" in its place.
33	Sec. 3. Fiscal impact statement.
34	The Council adopts the fiscal impact statement of the Budget Director as the fiscal impact
35	statement required by section 4a of the General Legislative Procedures Act of 1975, approved
36	October 16, 2006 (120 Stat. 2038; D.C. Official Code § 1-301.47a).
37	Sec. 4. Effective date.
38	(a) This act shall take effect following approval by the Mayor (or in the event of veto by
39	the Mayor, action by the Council to override the veto), a 30-day period of congressional review
40	as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December
41	24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
42	Columbia Register.
43	(b) This act shall expire after 225 days of its having taken effect.
