16	act may be cited as the "Minor Access to Medical Records and Appointments Regulations
17	Amendment Act of 2023."
18	Sec. 2. Chapter 6 of Title 22-B of the District of Columbia Municipal Regulations (22-B
19	DCMR § 600) is amended by adding a new subsection 600.10 to read as follows:
20	"600.10 (a) A minor who is sixteen (16) years of age or more and enrolled in a Medicaid
21	or DC HealthCare Alliance health benefits plan may:
22	"(1) Request their medical records from a health care provider without parental
23	consent; and
24	"(2) Make medical appointments and consent to the provision of health services
25	for themselves without parental consent; provided, that the minor is capable of meeting the
26	informed consent standard.
27	"(b) For the purposes of this subsection, the term:

28	"(1) "Health services" means primary care, dental, and vision health services, but
29	shall not include specialist care, emergency care, surgery, or vaccinations; provided, that nothing
30	in this definition shall be construed to limit or prevent a minor from seeking any health service
31	that a minor is otherwise entitled to under any other provision in this chapter.
32	"(2) "Informed consent standard" means the minor is able to comprehend the need for,
33	the nature of, and any significant risks ordinarily inherent in the health services to be provided.".

36	impact statement required by section 4a of the General Legislative Procedures Act of 1975,

39	This act shall take effect following approval by the Mayor (or in the event of veto by the
40	Mayor, action by the Council to override the veto), a 30-day period of congressional review as
41	provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December
42	24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
43	Columbia Register.
