IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

---

To amend, on an emergency basis, due to congressional review, the Legalization of Marijuana for Medical Treatment Initiative of 1999 to provide that it is unlawful for a licensed or unlicensed cultivation center, manufacturer, retailer, or internet retailer to represent that goods or services or the business is compliant with the Legalization of Possession of Minimal Amounts of Marijuana for Personal Use Initiative of 2014, to authorize the Alcoholic Beverage and Cannabis Board to extend the 45-calendar day public comment period by an additional 30-calendar days in response to a written request submitted by either an affected Advisory Neighborhood Commission or the applicant, to clarify that an Advisory Neighborhood Commission within 600 feet of where an establishment is or will be located has standing to protest the issuance of a license to an unlicensed cultivation center, manufacturer, retailer, or internet retailer, to align the enforcement procedures with those provided in Title 25 of the District of Columbia Official Code, and to clarify that the Alcoholic Beverage and Cannabis Board has the authority to issue cease-and-desist orders mandating compliance with the provisions of the Medical Cannabis Program; and to amend the Medical Cannabis Amendment Act of 2022 to clarify that the Alcoholic Beverage and Cannabis Board has authority to enforce against commercial property owners of properties that are used to operate illegal cannabis businesses.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the “Medical Cannabis Program Enforcement Congressional Review Emergency Amendment Act of 2024”.

Sec. 2. The Legalization of Marijuana for Medical Treatment Initiative of 1999, effective February 25, 2010 (D.C. Law 13-315; D.C. Official Code § 7-1671.01 *et seq.*), is amended as follows:

39 (a) Section 7 (D.C. Official Code § 7-1671.06) is amended by adding a new subsection (c-  
40 1) to read as follows:

41 “(c-1) It shall be a violation of this act for any unlicensed or licensed cultivation center,  
42 manufacturer, retailer, or internet retailer to represent that goods or services or the business is  
43 compliant with the Legalization of Possession of Minimal Amounts of Marijuana for Personal Use  
44 Initiative of 2014, effective February 26, 2015 (D.C. Law 20-153; D.C. Official Code § *passim*);  
45 except, that a licensed cultivation center, manufacturer, retailer, or internet retailer may have  
46 signage indicating that there is medical cannabis on the property.”.

47 (b) Section 7a(h) (D.C. Official Code § 7-1671.06a(h)) is amended to read as follows:

48 “(h)(1) The ABC Board shall provide notice of complete and eligible cultivation center,  
49 retailer, and internet retailer license applications received from unlicensed establishments to the  
50 Ward Councilmember, and any Advisory Neighborhood Commission within 600 feet of where the  
51 establishment is or will be located (“affected ANC”), for a 45-calendar day public comment period.  
52 The ABC Board may extend the public comment period required by this paragraph by an additional  
53 30-calendar days in response to a written request submitted by either an affected ANC or the  
54 applicant.

55 “(2) An affected ANC may protest the issuance of the license.

56 “(3) The ABC Board shall hold a contested case protest hearing within 120 days of  
57 receiving a timely protest from an affected ANC pursuant to paragraph (2) of this subsection.

58 “(4) The provisions of this subsection shall apply to all applications submitted to  
59 ABCA after the effective date of the Medical Cannabis Program Enforcement Emergency  
60 Amendment Act of 2024, effective January 25, 2024 (D.C. Act 25-371; 71 DCR 1200).”.

61 (c) Section 7b (D.C. Official Code § 7–1671.06b) is amended by adding a new subsection  
62 (e) to read as follows:

63 “(e) An unlicensed establishment shall not display signage or imagery advertising relating  
64 to:

65 “(1) The prices of cannabis or cannabis product in the window;

66 “(2) Cannabis or a cannabis product on the exterior of any window or on the exterior  
67 or interior of any door; or

68 “(3) Cannabis or a cannabis product on the exterior or visible from the exterior of  
69 the unlicensed establishment or elsewhere in the District.”.

70 (d) Section 9 (D.C. Official Code § 7–1671.08) is amended as follows:

71 (1) Subsection (d) is amended by striking the phrase “licensed cultivation” and  
72 inserting the phrase “licensed or unlicensed cultivation” in its place.

73 (2) A new subsection (f) is added to read as follows:

74 “(f) Beginning January 31, 2024, the ABC Board may issue the following fines to an  
75 unlicensed establishment that violates section 7(c-1) or section 7b(e), or has not filed an accepted  
76 and pending application with the ABC Board and knowingly engages or attempts to engage in the  
77 purchase, sale, exchange, delivery, or any other form of commercial transaction involving cannabis  
78 that is not purchased, sold, exchanged, or delivered in accordance with the provisions of this act  
79 or section 401 of the District of Columbia Uniform Controlled Substances Act of 1981, effective  
80 August 5, 1981 (D.C. Law 4-29; D.C. Official Code § 48-904.01):

81 “(1) For the first violation, the ABC Board may issue a written warning to the  
82 unlicensed establishment;

83 “(2) For the second violation, the ABC Board may:

84                               “(A) Issue a fine in the amount of \$10,000; and

85                               “(B) Require the unlicensed establishment to submit a remediation plan to  
86 the ABC Board that contains the unlicensed establishment’s plan to prevent any future recurrence  
87 of purchasing, selling, exchanging, delivering, or otherwise transacting any cannabis that is not  
88 purchased, sold, exchanged, or delivered in accordance with the provisions of this act or section  
89 401 of the District of Columbia Uniform Controlled Substances Act of 1981, effective August 5,  
90 1981 (D.C. Law 4-29; D.C. Official Code § 48-904.01); and

91                               “(3) For any subsequent violations or if the unlicensed establishment fails to submit  
92 a remediation plan in accordance with paragraph (2) of this subsection, or if the ABC Board rejects  
93 the unlicensed establishment’s remediation plan, the ABC Board may issue additional fines.”.

94                               (e) Section 13a (D.C. Official Code § 7-1671.12a) is amended as follows:

95                               (1) Subsection (a) is amended by striking the phrase “Board or the Mayor” both  
96 times it appears and inserting the word “Board” in its place.

97                               (2) Subsection (d) is amended by striking the phrase “Board or the Mayor” and  
98 inserting the word “Board” in its place.

99                               (3) Subsection (f) is amended by striking the phrase “Board or the Mayor” and  
100 inserting the word “Board” in its place.

101                               (f) New sections 13b, 13c, 13d, and 13e are added to read as follows:

102                               “Sec. 13b. Examination of premises, books, and records.

103                               “(a) An applicant for a license, and each licensee, shall allow any ABCA investigator, agent  
104 of the ABC Board, or any member of the Metropolitan Police Department full opportunity to  
105 examine, at any time during business hours:

106                   “(1) The premises where a cannabis product is manufactured, kept, sold, or  
107 consumed for which an application for a license has been made or for which a license has been  
108 issued; and

109                   “(2) The books and records of the business for which an application for a license  
110 has been made or for which a license has been issued.

111                   “(b) ABCA investigators shall examine the premises and books and records of each  
112 licensed establishment in the District at least once each year. The investigators shall make  
113 reasonable efforts to ensure that the licensee shall know in advance the date of the inspection.

114                   “Sec. 13c. Search warrants for illegal cannabis products; disposition of seized products.

115                   “‘If a search warrant is issued by any judge of the Superior Court of the District of Columbia  
116 or by a United States Magistrate for the District of Columbia for premises where any cannabis  
117 products are sold, exchanged as part of a commercial transaction, delivered, or permitted to be  
118 consumed in violation of this title, the cannabis product and any other property designed for use  
119 in connection with the unlawful manufacture for sale, keeping for sale, selling, or consumption  
120 may be seized and shall be subject to such disposition as the court may make thereof.

121                   “Sec. 13d. Notifications from Department of Licensing and Consumer Protection, Office  
122 of Tax and Revenue, Fire and Emergency Medical Services Department, and Metropolitan Police  
123 Department.

124                   “(a) The Department of Licensing and Consumer Protection, the Office of Tax and  
125 Revenue, and the Fire and Emergency Medical Services Department shall notify the ABC Board  
126 if a licensed establishment is the subject of a citation, revocation, or other enforcement action for  
127 a violation of laws or regulations enforced by those agencies or offices within 30-calendar days  
128 after the citation, revocation, or other enforcement action.

129           “(b) If a licensed establishment is the subject of an incident report by the Metropolitan  
130 Police Department, the Metropolitan Police Department shall file a copy of the incident report with  
131 the ABC Board within 30-calendar days after the incident. The ABC Board shall make the report  
132 available for public inspection upon request.

133           “Sec. 13e. Nuisance.

134           “(a) Any building, ground, or premises where cannabis is sold, exchanged as part of a  
135 commercial transaction, delivered, or permitted to be consumed by an unlicensed establishment  
136 shall be a nuisance, except any building, ground, or premises of an applicant that filed an accepted  
137 and pending application with the Board during the 90-calendar day open application period.

138           “(b) An action to enjoin any nuisance defined in subsection (a) of this section may be  
139 brought in the name of the District of Columbia by the Attorney General for the District of  
140 Columbia in the Civil Branch of the Superior Court of the District of Columbia against any person  
141 conducting or maintaining such nuisance or knowingly permitting such nuisance to be conducted  
142 or maintained.”.

143           Sec. 3. The Medical Cannabis Amendment Act of 2022, effective March 22, 2023 (D.C.  
144 Law 24-332; 70 DCR 1582), is amended as follows:

145           (a) Section 8 (D.C. Official Code § 7-1675.01) is amended as follows:

146                   (1) Subsection (a) is amended as follows:

147                           (A) Paragraph (1) is amended as follows:

148                                   (i) The lead-in language is amended by striking the phrase  
149 “Alcoholic Beverage and Cannabis Administration makes final determinations for the licensure of  
150 unlicensed establishments pursuant to §§ 7-1671.06a and 7-1671.06b, for the first violation  
151 of D.C. Official Code § 47-2844(a-2)(1B), the Mayor” and inserting the phrase “Alcoholic

152 Beverage and Cannabis Board (“ABC Board”) makes final determinations for the licensure of  
153 unlicensed establishments pursuant to sections 7a and 7b of the Legalization of Marijuana for  
154 Medical Treatment Initiative of 1999, effective March 22, 2023 (D.C. Law 24-332; D.C. Official  
155 Code §§ 7-1671.06a and 7-1671.06b), for the first violation of section 9(f) of the Legalization of  
156 Marijuana for Medical Treatment Initiative of 1999, effective July 27, 2010 (D.C. Law 18-210;  
157 D.C. Official Code § 7-1671.08(f)), the ABC Board ” in its place.

158 (ii) Subparagraph (C) is amended by striking the phrase “D.C.  
159 Official Code § 47-2844(a-2)(1B)” and inserting the phrase “section 9(f) of the Legalization of  
160 Marijuana for Medical Treatment Initiative of 1999, effective July 27, 2010 (D.C. Law 18-210;  
161 D.C. Official Code § 7-1671.08(f))” in its place.

162 (B) Paragraph (2) is amended by striking the phrase “provided to the  
163 Alcoholic Beverage and Cannabis Administration,” and inserting the phrase “provided to” in its  
164 place.

165 (2) Subsection (b) is amended as follows:

166 (A) The lead-in language is amended by striking the phrase “D.C. Official  
167 Code § 47-2844(a-2)(1B)” and inserting the phrase “section 9(f) of the Legalization of Marijuana  
168 for Medical Treatment Initiative of 1999, effective July 27, 2010 (D.C. Law 18-210; D.C. Official  
169 Code § 7-1671.08(f))” in its place.

170 (B) Paragraph (1) is amended by striking the phrase “The Mayor” and  
171 inserting the phrase “The ABC Board” in its place.

172 (C) Paragraph (2) is amended as follows:

173 (i) Subparagraph (A) is amended to read as follows:

174                   “(A) The ABC Board shall require the commercial property owner to submit  
175 a remediation plan within 14 days after the notice of a fine under paragraph (1) of this subsection  
176 to the ABC Board that contains the commercial property owner's plan to prevent any future  
177 violations of section 9(f) of the Legalization of Marijuana for Medical Treatment Initiative of  
178 1999, effective July 27, 2010 (D.C. Law 18-210; D.C. Official Code § 7-1671.08(f)).”.

179                   (ii) Subparagraph (B) is amended by striking the phrase “the Mayor,  
180 in consultation with the Director of the Department of Licensing and Consumer Protection, rejects  
181 the commercial property owner's remediation plan, the Mayor may issue additional fines or revoke  
182 the commercial property owners’ licenses” and inserting the phrase “the ABC Board rejects the  
183 commercial property owner’s remediation plan, the ABC Board may issue additional fines” in its  
184 place.

185                   (3) Subsection (c) is amended as follows:

186                   (A) Paragraph (1) is amended by striking the phrase “Office of  
187 Administrative Hearings” and inserting the phrase “Alcoholic Beverage and Cannabis Board  
188 (“ABC Board”)” in its place.

189                   (B) Paragraph (2) is amended by striking the phrase “Office of  
190 Administrative Hearings” and inserting the phrase “ABC Board” in its place.

191                   (C) Paragraph (3) is amended by striking the phrase “administrative law  
192 judge” and inserting the phrase “ABC Board” in its place.

193                   (4) Subsection (e)(1) is amended by striking the phrase “Office of Administrative  
194 Hearings” and inserting the phrase “ABC Board” in its place.

197 phrase “and 7” in its place.

198 (2) Subsection (c)(2) is amended by striking the phrase “this act” and inserting the  
199 phrase “the provisions identified in subsection (a) of this section” in its place.

200 Sec. 4. Fiscal impact statement.

201 The Council adopts the fiscal impact statement of the Budget Director as the fiscal impact  
202 statement required by section 4a of the General Legislative Procedures Act of 1975, approved  
203 October 16, 2006 (120 Stat. 2038; D.C. Official Code § 1-301.47a).

204 Sec. 5. Effective date.

205 This act shall take effect following approval by the Mayor (or in the event of veto by the  
206 Mayor, action by the Council to override the veto), and shall remain in effect for no longer than  
207 90 days, as provided for emergency acts of the Council of the District of Columbia in section  
208 412(a) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 788;  
209 D.C. Official Code §1-204.12(a)).
