Cheh 3 A CEREMONIAL RESOLUTION 4 IN THE COUNCIL OF THE DISTRICT OF COLUMBIA 5 6 7 Recognizing and celebrating the exceptional achievements and long-time dedicated service of District resident and activist, Louise White. 8 9 WHEREAS, Louise White is a longtime resident of Ward 3 in the District of Columbia, and has a distinguished academic career as a Professor at American and at George Mason 10 Universities. 11 12 WHEREAS, Through her service on the Mission Committee of the Chevy Chase 13 Presbyterian Church, Louise White became familiar with the plight of returning citizens and the hurdles faced when reentering their communities. 14 15 WHEREAS, In September 2005, she began building a volunteer advocacy group, The Reentry Task Force, to focus on issues of confinement and reentry; this task force has held 16 17 monthly meetings since 2006. WHEREAS, Benefiting from Ms. White's leadership, energy, and networking skills, The 18 Reentry Task Force grew exponentially within a year of its formation. Members included 19 20 representatives from neighborhood churches, the D.C. Public Defender Service, the D.C. Prisoners' Project of the Washington Lawyers' Committee, and the large community of returning 21 citizens, themselves. 22 WHEREAS, Since 2006, Louise White has ensured that the Reentry Task Force remains 23 active and vocal by meeting with D.C. Councilmembers, the D.C. Department of Corrections, 24 25 halfway house operators, and Delegate Eleanor Holmes Norton. Louise White and other Task Force members have remained involved in the legislative process by providing testimony 26 regularly at public legislative, oversight, and budget hearings of the D.C. Council paying special 27 attention to the Committee on the Judiciary. 28
