Health Organization and what is now the Commission on Accreditation of Healthcare

44	WHEREAS, in 1981, Dr. Darr served as a Visiting Professor at The American University
45	in Cairo, Egypt;
46	WHEREAS, in 1982, Dr. Darr served as a Visiting Professor at the Nuffield Centre for
47	International Health and Development at the University of Leeds in England;
48	WHEREAS, Dr. Darr served as a Visiting Scholar at the Institute for Health Services
49	Research and Policy Studies at Northwestern University in 1996-1997;
50	WHEREAS, as a faculty member at The George Washington University, Dr. Darr has
51	been steadfast in his devotion to the school and has served on the University Faculty Senate, the
52	Medical Center Faculty Senate, the Department Curriculum Committee, the Department
53	Appointment, Promotion, and Tenure Committee, as well as Parliamentarian for the Milken
54	Institute School of Public Health;

55	WHEREAS, Dr. Darr has penned several books on the topic of health service
56	management as well as many scholarly articles in both health and law journals;
57	WHEREAS, Dr. Darr is a member of the American College of Healthcare Executives, the
58	American Hospital Association, the National Capital Healthcare Executives, the American
59	Society for Quality, the American Bar Association, the District of Columbia Bar Association, the

61	WHEREAS, Dr. Darr has educated over 1,500 healthcare leaders, executives and
62	managers, was honored by the George Washington Student Association with the Excellence in
[,] 63	Teaching award ten times, and received the Trachtenberg Award for University Service in 2009;

65	District of Columbia and the health community;
