WHEREAS, over 6 million Americans have developmental disabilities, and residents with developmental disabilities are our friends, family, and neighbors in every Ward of the District of Columbia: WHEREAS, government agencies, community organizations, and individual and family leaders work together to ensure that people with developmental disabilities experience full access

to education, housing, employment, recreational activities, and other community resources;

72	resolution may be cited as the "Developmental Disabilities Awareness Month Recognition
73	Resolution of 2024".
