



Dr. Bernard received her Pharm.D. from the Howard University College of Pharmacy and completed the American Association of Colleges of Pharmacy Academic Leadership Fellowship. She is a Board Certified Anticoagulation Care Provider and completed the Ambulatory Pharmaceutical Care Certification Program with the University of Illinois at Chicago College of Pharmacy sponsored by Kaiser Permanente. Also, she completed the American Society of Health-System Pharmacists Anticoagulation Traineeship at the University of Washington Medical Center. Dr. Bernard successfully implemented the Anticoagulation Management Service at Howard University Hospital in November of 1999 which serves a vital role in the hospital's effort to improve drug therapy management. She is a licensed pharmacist in the states of Maryland, Virginia and the District of Columbia.

Dr. Bernard is a frequent speaker on anticoagulation therapy, self-care, and curriculum enhancement and has been an invited presenter at numerous annual meetings including the Association of Institutional Research Annual Meeting, American Pharmacists Association Annual Meeting, American Society of Health-System Pharmacists Clinical Midyear Meeting, the Nonprescription Medicines Academy, and the American Association of Colleges of Pharmacy. Dr. Bernard is the previous editor of the District of Columbia Board of Pharmacy's newsletter and has published in several peer-reviewed journals. She has served as a journal reviewer for the American Journal of Health Systems Pharmacy, Annals of Pharmacotherapy, Journal of Pharmacy Technology, and Hospital Pharmacy. Dr. Bernard is a chapter author in the Handbook of Nonprescription Therapy. She has also adapted cases for the Textbook for Therapeutics: Drug and Disease Management and has reviewed several textbooks, including the American Society of Health-System Pharmacists' Anticoagulation Management Module.

Dr. Bernard is a member of the Anticoagulation Forum, National Association of Boards of Pharmacy, District of Columbia Board of Pharmacy, the Nonprescription Medicines Academy, Rho Chi Honor Society, American Pharmaceutical Association, American Association of Colleges of Pharmacy, and Kappa Epsilon Fraternity. She is a regular community volunteer and has participated in numerous health fairs conducted across the Howard University campus and throughout the Metropolitan area.

Currently, Dr. Bernard's research emphasis is in the areas of curriculum assessment and health systems quality improvement.
