Career Summary

Lydia joined the National Park Foundation as executive director of the African American Experience Fund (AAEF) on December 1, 2010, after a distinguished career of service at the White House, in federal and local government and in the nonprofit and private sectors.

She brings to the AAEF more than 25 years of collective experience in public relations; strategic, crisis, branding, marketing and new media communications; organizational and executive management; fundraising; government affairs; community relations, strategic partnership alliances; events and conference planning and TV/radio production.

Lydia previously served in private sector as a senior vice president in the DC Office of Fenton, a public interest communications firm, where she was a member of the senior management team and the Public Health, Women's, African American and local government practice areas. She served as a vice president of the DC-based PR firm Walker Marchant Group.

In the nonprofit sector, she served as director of Communications and Public Affairs for the American Psychiatric Association and led the creation and launch of their legacy "Healthy Minds. Healthy Lives" public information campaign. As senior vice-president of Communications and Marketing for the National Foundation for Credit Counseling (NFCC), she led rebranding and advocacy campaigns for the nation's oldest and original CCCS agencies to increase public awareness of consumer credit & financial management services and consumer-friendly advisers. Her public relations career began in 1990 at the Children's Hospital of Philadelphia (PA), as a public relations and community relations manager.

Lydia's other private sector work includes positions as a television producer for several TV network affiliates (WCAU-TV 10, Philadelphia., PA and WTNH-TV 8, New Haven, CT).

Lydia earned a B.A. in Communications from Temple University and a M.A. in Broadcast Journalism and Public Affairs from American University.
