Resolution of 2014".

Chairman Phil Mendelson, at the request of the Mayor, introduced the following resolution,

Sec. 2. The Council of the District of Columbia confirms the reappointment of:

Lafayette Barnes 114 Mississippi Avenue, S.E. Washington, D.C. 20032 (Ward 8)

as a public voting member of the Commission on African Affairs, established by section 5 of the Office and Commission on African Affairs Act of 2006, effective June 8, 2006 (D.C. Law 16-111; D.C. Official Code § 2-1394), and in accordance with section 2 of the Confirmation Act of 1978, effective March 3, 1979 (D.C. Law 2-142; D.C. Official Code § 1-523.01), for a term to end October 27, 2017.

Capacity Building Training

- Led the Office of Partnerships and Grant Services' (OPGS) development of two capacity building programs entitled, the Strengthening Partners Initiative and the Effi Barry HIV/AIDS Capacity Building Program, for some 250 emerging nonprofits in the District of Columbia;
- Organized two Sister City HIV/AIDS best practice prevention video conferences hosted by the World Bank for South African and American senior public health and nonprofit leaders from the City of Tshwane/Pretoria in South Africa and Washington, DC in 2008 and 2009; and
- Established a South African Fellows Exchange Program between OPGS and the Umlambo Foundation founded by Ms. Phumzile Mlambo-Ngcuka the former Deputy President of South Africa in 2009.

External Affairs

- Led the Executive Office of the Mayor's outreach efforts to engage over 5000 DC residents and stakeholders in Mayor Williams' Citizen Summits, a participatory democracy exercise, to obtain broad public input in the city's strategic planning and budget formulation process;
- Guided the Mayor's Executive Office efforts to draft and adopt the conditions for signing the Protocol
 Agreements on Cooperation between the Mayors of the City of Tshwane/Pretoria in South Africa and
 the District of Columbia in September 2008 and June 2002; and
- Served as advance staff for Mayor Williams and the DC Delegation's Trade and Cultural Mission to Dakar, Senegal, arranged the official meetings and signing ceremony to renew the District of Columbia's Sister City Agreement with the City of Dakar in May 2006.

Grant and Resource Development:

- Established the Office of Partnerships and Grants Development (OPGD) in the Executive Office of the Mayor in 2001 and later began an independent Cabinet level agency called the Office of Partnerships and Grant Services (OPGS) in 2008;
- Augmented the District government's centralized grant development functions which has enhanced its
 competitive grants seeking and submission processes and attributed to the receipt of over \$220M in new
 federal grant awards since its inception; and
- Developed the District's Rules of Conduct for soliciting, accepting, and using private donations which
 has resulted in authorizing the receipt of \$40M in contributions made to the DC government agencies
 since 2002.

Grant-making Oversight and Management

- Organized the government's efforts to produce a uniform set of policies and procedures for awarding, monitoring, and reporting on DC agencies' competitive grants and sub-grants making activities and thus promote greater efficiency and conformity in this process;
- Oversaw the design of OPGS' Grants Made Database, a pilot project, to enhance the City Administrator's capacity to monitor government grant and sub-grant awards as well as recommend new policies and procedures to enhance this process; and
- Managed the Freddie Mac Foundation's grant review process for some 350 proposals that resulted in the award of approximately \$9M in grants to nonprofit organizations operating throughout the United States.

- Hired and coached a diverse and talented team who has successfully managed OPGS' core functions
 and achieved the office's annual performance goals and objectives while consistently obtaining high
 levels of customer satisfaction for the delivery of its critical services;

 plan and its related outcomes; and
