Artistic Statment

I am a multi disciplined creative professional that is constantly exploring texture, dimension and function.

With so much architectural design and construction underway in the District, I have been inspired to further explore dimension. As a result, I have being designing and rendering many more 3d models of art installations, streetscapes and functional art in Google Sketchup than usual. It is import for me to able to provide structural art and design solutions that beautify, and compliment with existing indoor and outdoor environments while interacting with it's inhabitants.

The use of texture in culinary applications provides a spectrum of satisfaction from crispy to gelatinous. Although texture does not directly provide flavor, it is highly influential in determining the satisfaction of the consumer. I apply texture to create a dimension the cannot be measured by width, length or height, but its impact on a finished work often allow the audience to assume and even comprehend how a surface may feel without even touching it. My use of texture is influenced and further developed by constantly surveying materials born of the natural environment as well as those materialized from the imaginations of men and women.

Function is a key part of my creative interests. I made a mosaic a while ago that incorporated a glass shelf. During the summer of 2012 I created a 3-section painting on ply and ended up converting it to a self that maintained the original integrity of the painting. During the summer of 2013 I created a backlit piece of art that provides soft light. I also revamped signage for a local environmental center. I am interested in assuring that my art and design meets functional needs such as lighting, shelving, way finding and seating.

I frequent resale businesses to keep a diverse supply of creative material and much of what I have produced in the past two years is with repurposed materials. I have always been one to take something sitting beside a dumpster and repurpose it. This also contributes to earth conservation by recycling via my art.
