Dear Chairman Mendelson:

Enclosed for consideration and approval by the Council of the District of Columbia is proposed emergency resolution, the "Contract No. DCKA-2017-C-0052 with RAPT Dev North America/McDonald Transit Associates, Inc. Emergency Approval Resolution of 2018," and the accompanying emergency declaration, to approve multiyear Contract No. DCKA-2017-C-0052 to provide operation and maintenance services for the DC Circulator bus routes. Approval is necessary to allow the District to continue to receive the benefit of these vital services without interruption, and the critical requirements of the District can only be met through an award of the multiyear contract.

Council approval is required by section 451(c)(3) of the District of Columbia Home Rule Act, approved December 24, 1973, 87 Stat. 803, Pub. L. 93-198; D.C. Official Code § 1-204.51(c)(3).

The term of contract will be five years and three months from the date of award at a not-to-exceed amount of \$140,732,227.69. The Chief Financial Officer for the District Department of Transportation has certified that funding is available for FY 2018 and that the proposed contract is within the District's financial plan and budget.
